Comes now Knott County Water & Sewer District (“KCWSD”), by and through the undersigned counsel, and requests an extension of time to file the responses to Commission Staff’s Request Nos. 3 and 5 issued on January 4, 2021. As grounds for this motion KCWSD respectfully states as follows:

KCWSD requested clarification from Commission Staff regarding Request Nos. 3 and 5 of the Commission’s January 4, 2021 Requests for Information. Commission Staff provided the clarifications on Monday, January 11, 2021. KCWSD’s Chief Financial Officer, Kyle Smith reviewed the information provided by Commission Staff and was attempting to gather the information needed for these responses. However, Mr. Smith has had to be placed into quarantine due to COVID-19 contact tracing. Mr. Smith is in the process of obtaining his items needed from his office to continue to draft the responses to the remaining Requests for Information but that will not be completed in time to meet today’s filing deadline. KCWSD is requesting an extension until Friday, January 22, 2021 to file the remaining information.

Furthermore, Mr. Smith is the witness responsible for each of the responses contained in Commission Staff’s Requests for Information. His Verification will be filed when the remaining data request responses are filed by KCWSD and he is able to have it notarized.
