RENEWED REQUEST FOR RELIEF

Comes now the Applicant, Henderson County Solar LLC (“Applicant” or “Henderson Solar”), by and through counsel, and respectfully submits this Renewed Request for Relief in light of upcoming project deadlines and respectfully **REQUESTS A DECISION BY FEBRUARY 1, 2026**. In support of this request, Henderson Solar states as follows:

On June 25, 2021, Henderson Solar filed an application with the Kentucky State Board on Electric Generation and Transmission Siting (“Siting Board” or “Board”) for a certificate to construct an approximately 50 megawatt (MW) merchant electric generating facility in Henderson County, Kentucky (the “Project”). On December 22, 2021, the Siting Board approved the construction certificate to construct the Project. As part of the Project’s approval, the Siting Board required Henderson Solar to comply with certain mitigation measures contained in Appendix A to the construction certificate. Among those measures is Mitigation Measure No. 26, which provides as follows:

26. If any person shall acquire or transfer ownership of, or control, or the right to control the Project, by sale of assets, transfer of stock, or otherwise, or abandon the same, Henderson County Solar or its successors or assigns shall request explicit approval from the Siting Board with notice of the request provided to the Henderson County Fiscal Court. In any application requesting such abandonment, sale or

change of control, Henderson County Solar shall certify its compliance with KRS 278.710(1)(i).

On September 24, 2025, Henderson Solar submitted a request to the Siting Board to approve the transfer of the Project from AES Clean Energy Development, LLC to Stellar US Asset Co LLC, a wholly owned subsidiary of Stellar Renewable Power LLC (“Stellar Renewable Power”), which occurred on April 11, 2024.¹

Henderson Solar is preparing to submit its final site plan to the Siting Board and subsequently commence construction of the Project as early as the first week of February. Mitigation Measure No. 26 requires Henderson Solar to request explicit approval from the Siting Board regarding the ownership transfer described above. Henderson Solar has complied with the strict requirements of that Mitigation measure by requesting approval on September 24, 2025. However, Henderson Solar now provides this renewed request to give the Board an opportunity to respond prior to the commencement of construction.

As such, Henderson Solar respectfully requests the Board to approve the transfer of the Project by February 1, 2026. Having complied with the Board’s Mitigation Measure 26, Henderson Solar will otherwise proceed with commencement of construction in February.
