MCCRACKEN COUNTY SOLAR LLC'S
NOTICE OF INTENT

Comes now McCracken County Solar LLC, by counsel, pursuant to KRS 278.700, *et seq.*, 807 KAR 5:110, Section 2 and other applicable law, and does hereby tender its NOTICE OF INTENT to file an application, on or before May 31, 2021, for a Certificate to Construct an approximately 60 megawatt (“MW”) merchant solar electric generating facility in McCracken County, Kentucky (the “McCracken County Solar Project”), respectfully stating as follows:

1. Pursuant to 807 KAR 5:110, Section 2(2)(a), the forthcoming application will be filed by McCracken County Solar LLC, Three Radnor Corporate Center, Suite 300, 100 Matsonford Road, Radnor, PA 19087. The applicant’s telephone number is: (866) 946-3123 and its email address is: info@communityenergyinc.com.

2. Pursuant to 807 KAR 5:110, Section 2(2)(b), the McCracken County Solar Project will be capable of generating approximately 60 MWs of electricity from a solar array covering a total of approximately 752 acres. This acreage is located in McCracken County, Kentucky, near

the town of Kevil. The project includes approximately 156,000 photovoltaic solar panels, associated racking, 84 inverters and a project substation transformer that will interconnect to an existing 69 kV transmission line owned by Big Rivers Electric Corporation at a location near 4940 New Liberty Church Rd., Kevil, KY 42053.

3. Pursuant to 807 KAR 5:110, Section 2(2)(c), the McCracken County Solar Project is located in McCracken County, KY, northeast of the town of Kevil. The street address for the McCracken County Solar Project is New Liberty Church Rd., Kevil, KY 42053 and its coordinates are: 37°7'20.99"N latitude and 88°51'40.45"W longitude. No portion of the McCracken County Solar Project is located within the boundaries of any municipality.

4. Pursuant to 807 KAR 5:110, Section 2(2)(d), the address of the McCracken County Planning and Zoning Commission is 300 Clarence Gaines Street, Paducah, Kentucky 42003.

5. Pursuant to 807 KAR 5:110, Section 2(2)(e), the McCracken County Planning and Zoning Commission has not adopted a setback requirement for commercial solar electric generation facilities within its boundaries.

6. Pursuant to 807 KAR 5:110, Section 2(2)(f), in the absence of a lesser setback requirement from the McCracken County Planning and Zoning Commission, it is anticipated that a deviation will be requested as part of the application.
