**NOTICE OF FILING**

COMES NOW, Navitas KY NG, LLC (“Navitas”), by and through counsel, and hereby submits this Notice of Filing of the following document in this Docket No. 2020-00396:

Per the April 27, 2021 Order in Case No. 2020-00396, Navitas now files the following:

- a. The Navitas KY NG, LLC tariff pursuant to the April 27, 2021 Order. For the convenience of the Commission, Navitas is submitting a clean document and a strikethrough copy. Changes made to the tariff are as follows:
  - i. Page 2: Pursuant to the April 27 Order, Navitas KY has added language reflecting its’ obligations under the customer refund for its Johnson County and Floyd County customers; Navitas’ Johnson County and Floyd County customers now share the same Johnson County base rate of \$8.60; the correct GCR rates from the prescribed cases have been included.
  - ii. Page 4: On page 4, Section b. Reconnection Charge, the reconnection charge has been changed from \$25.00 to \$26.00 to reflect the Johnson County Gas tariff.

- iii. Page 5: On page 5, Section d. Delayed Payment charges, the delayed payment charge has been changed from 5% to 10% to reflect the Johnson County Gas tariff.
- iv. Page 6: On page 6, Customer Inquiries, Navitas KY has deleted the prescribed business hours.
- v. Page 10: On page 10, Navitas has deleted certain language related to the deposit procedure and customer class differences and created a unified deposit of 2/12<sup>th</sup> of the customer's actual or estimated annual bill.
