MOTION TO AMEND ORDER OF MARCH 11, 2021

McCreary County Water District ("McCreary District") moves to amend the Order of March 11, 2021 to state the amount of the authorized loan from the Kentucky Infrastructure Authority ("KIA") as \$3,244,500. In support of its Motion, McCreary District states:

1. On January 15, 2021, McCreary District applied to the Kentucky Public Service Commission ("Commission") for, among other things, authorization to enter an Assistance Agreement with KIA to borrow **\$3,244,500** to finance its Sanitary Sewer Collection System Expansion Phase 1 Project. While McCreary District stated the amount of the loan as \$3,244,500 throughout the Application, it misstated the amount of the loan as \$3,224,500 on the first page of the Application when describing the Application's purpose. This error appears to have created some confusion as to the amount of the loan for which authorization was sought.

2. On March 11, 2021, the Commission entered an Order that, among other things, authorized McCreary District to enter an Assistance Agreement with KIA to borrow an amount not to exceed **\$3,224,500**.

3. In its Order of March 11, 2021, the Commission states the amount of the requested loan as \$3,224,500 on the following pages:

- a. At page 1, first paragraph, second sentence, line 5;
- b. At page 2, second paragraph, first sentence, line 16;
- c. At page 2, second paragraph, second sentence, line 17;
- d. At page 4, Finding No. 6;
- e. At page 5, Finding No. 7; and
- f. At page 5, Ordering Paragraph 5.

WHEREFORE, McCreary County Water District requests that the Commission amend

its Order of March 11, 2021 to state the amount of the authorized KIA loan as \$3,244,500.
