**APPLICATION TO CONSTRUCT
MERCHANT ELECTRIC GENERATING FACILITY**

Pursuant to KRS 278.706 and 807 KAR 5:110, Horus Kentucky 1 LLC (“Horus” or “Applicant”), by counsel, submits this application for a construction certificate to construct a merchant electric generating facility. In support of this application, Horus states as follows:

1. Horus is a limited liability company organized under the laws of Delaware with a principal place of business of 110 Front Street, Suite 300, Jupiter, Florida 33477. Horus’s phone number is (617) 530-0029. A copy of Horus’s Certificate of Authority that is on file with the Kentucky Secretary of State’s office is submitted as Attachment I to this pleading.

2. The proposed Horus Kentucky 1 Project will consist of approximately 550 acres of solar photovoltaic panels and associated racking (approximately 69.3MW), 22 inverters, and a project substation transformer which will connect to the Tennessee Valley Authority’s L5402 – 161kv transmission line near the City of Franklin in Simpson County, Kentucky.

3. Pursuant to KRS 278.706 and 807 KAR 5:100, Horus hereby submits its application fee of \$ 69,300 with this filing.

4. Horus, through its counsel identified below, has the ability to receive electronic transmissions in this matter at the electronic mail addresses listed below.

5. Information required to be filed by statute and regulation is filed contemporaneously herewith. Please refer to the Application's Table of Contents and related information.
