Notice is hereby given that the Kentucky Public Service Commission (the "Commission") will conduct a public hearing beginning at 9:00 a.m. Eastern Daylight Savings Time on Tuesday, June 15, 2021 in the Richard Raff Hearing Room (Hearing Room 1) at its offices at 211 Sower Boulevard, Frankfort, Kentucky 40601. The hearing is scheduled to continue on June 16, 2021 beginning at 9:00 a.m. Eastern Daylight Savings Time and June 17, 2021 beginning at 9:00 a.m. Eastern Daylight Savings Time. The hearing is for the purposes of cross-examination of the witnesses of Kentucky Power Company and taking evidence on the issues in Case No. 2021-00004 regarding the Kentucky Power Company's request for approval of a certificate of public convenience and necessity to construct environmental projects at the Company's Mitchell Generating Station, and for approval of an amended Environmental Compliance Plan and revised Environmental Surcharge tariff sheets.
