**JOINT NOTICE OF KIUC AND THE ATTORNEY GENERAL  
REGARDING CANCELLATION OF HEARING**

---

The intervenors, the Attorney General of the Commonwealth of Kentucky, through his Office of Rate Intervention (“Attorney General”), and the Kentucky Industrial Utility Commission (“KIUC”), by counsel, provide notice that they do not object to the cancellation of the hearing scheduled in this matter as provided in the Commission’s Order of May 25, 2021.

However, the intervenors have data requests to which Kentucky Power has indicated it will provide supplemental responses. After Kentucky Power provides the requested information allowing for calculation of the abandonment loss benefit of a 2028 retirement, the Attorney General and KIUC expect to supplement the testimony of Mr. Kollen. The agreement of the Attorney General and KIUC that the hearing may be cancelled does not act to waive their entitlement to this supplementation, as those responses are necessary to the preparation of the required brief.
