NOTICE OF ANNUAL TARIFF REVIEW


Pursuant to the Commission’s Order of December 27, 2021, Ohio County Water District’s (“Ohio District” or “the District”) general manager conducted an annual review of Ohio District’s filed tariff on November 7, 2023 and found that current District practices and procedures do not conflict with or are contrary to the tariff’s provisions. The General Manager submitted a report of his findings, a copy of which is attached to this Notice as Exhibit 1, to Ohio District’s Board of Commissioners at its meeting on November 27, 2023. Legal counsel has concurred with the General Manager’s findings. The Board has accepted the General Manager’s report.

Since the first months of 2022 the District has conducted a separate, more comprehensive review of its existing tariff for the purpose of modernizing its tariff and ensuring it adequately protects the interests of the District and its ratepayers. The last such comprehensive review and revision of Ohio District’s tariff occurred in 2001. This review has been completed. A revised tariff was filed with the

Commission on April 1, 2024.¹ The District proposes to place the revised tariff in effect on May 1, 2024.

SUBJECT: General Manager's Annual Tariff Review Report

I conducted a review of the District's current tariff filed with the Kentucky Public Service Commission (PSC) on November 7, 2023. The rates and conditions of service in the tariff are being applied to all customers. The minor variations that were found from the November 28, 2022 annual tariff review have been addressed. No variations from tariff provisions were found during the annual review. Furthermore, clarifications of current procedures with the tariff are being reviewed by our attorney in an order to be consistent with recent PSC ruling and any statutory or regulatory changes.
