

Notice is hereby given that the Kentucky Public Service Commission (the "Commission") will conduct a virtual public hearing beginning at 9:00 a.m. Eastern Daylight Savings Time on Tuesday, May 18, 2021 in the Richard Raff Hearing Room (Hearing Room 1) at its offices at 211 Sower Boulevard, Frankfort, Kentucky 40601. The hearing is for the purposes of cross-examination of the witnesses in Case No. 2021-00053 on the application of Kentucky Power Company's Fuel Adjustment Clause from November 1, 2018 to October 31, 2020.
