10. OLD BUSINESS

 Rate Study: Trent Underwood presented the rate study findings from Alan Vilines with KRWA. Alan's findings showed a need of an 18.5% water rate increase. Also, the district can add on a Water Loss Reduction Surcharge, in the amount of \$1.73 a month per customer, for a maximum of 4 years.

In addition, the study resulted in findings of the need to raise the sewer rate 88.3%.

After much discussion, the board moved forward with a vote. Gary Esham made the motion to accept the finding for the water rate increase of 18.5%. Karin Collier seconded the motion, and Luke Bentley voted yes.

After reviewing the findings of the sewer rate increase, the board moved to take action on the matter. Although, they rejected the 88.3% increase, the board moved to approve a 35% increase for the sewer. Gary Esham made the motion, Karin Collier seconded, and Luke Bentley voted yes.

The Water Loss Reduction Surcharge was then discussed and voted on. Luke Bentley made the motion to accept the \$1.73 surcharge, Karin Collier seconded, and Gary Esham voted yes.

After the votes were passed, a resolution of the Board of Commissioners, proposing adjustments to the rates and charges, was then signed. This giving the manager permission, to go forward with the application with the PSC, seeking approval to the proposed rates.

Statement of Disclosure forms were filled out by each commissioner and the manager and notarized.

 2021 Budget: A vote of approval was needed for the 2021 budget. Gary Esham made a motion to accept the budget. Luke Bentley seconded the motion. Karin Collier voted yes.
