NOTICE OF FILING

Comes now East Kentucky Power Cooperative, Inc. (“EKPC”), by counsel, and hereby gives notice of the replacement of certain tariff sheets filed in this proceeding to replace previously expired versions of the same tariff sheets which were inadvertently included in EKPC’s application, respectfully stating as follows:


On April 1, 2021, EKPC filed its application for an adjustment to its rates. Exhibit 6 of that application includes revised tariff sheets for EKPC and Exhibit 7 includes the present tariff sheets indicating proposed additions by italicized inserts or underscoring and striking over proposed deletions. While preparing responses to the Commission Staff’s Second Information Request, EKPC discovered errors in the tariff sheets filed as part of its April 1, 2021 application. Specifically, incorrect versions of EKPC’s Rate H – Wholesale Renewable Energy Program were filed in Exhibit 6 of the Application, pages 21 and 22 of 24, and in Exhibit 7 of the Application, pages 25 and 26 of 28. As a result of an inadvertent oversight, EKPC filed the Rate H tariff sheets that were in effect prior to March 25, 2020. The current Rate H tariff was amended and approved

by the Commission in its March 25, 2020 Order in Case No. 2019-00378.¹ EKPC regrets this error and hereby replace the tariff sheets that are in error with the correct versions of the Rate H tariff sheets as an errata.

Attached to this notice are replacements for Exhibits 6 and 7 of the Application Rate H – Wholesale Renewable Energy Program tariffs reflecting the current version of the tariff and the changes proposed in this proceeding. The only changes are to delete the reference to Rate A in the “Standard Rider” section and the revision to the “Applicability” section.
