Comes now East Kentucky Power Cooperative, Inc. (“EKPC”), by and through counsel, and does hereby tender its motion for the hearing in this matter currently set for August 3 - 5, 2021 to be held in person at the Commission’s offices. In support of this motion EKPC respectfully states as follows:

1. On April 29, 2021, the Commission entered an Order setting this matter for a three-day hearing beginning August 3, 2021 and ending August 5, 2021. The Order reserved the right for the Commission to conduct the hearing in person instead of via video conference.
2. When the Order was issued, Kentucky was still under many restrictions due to the COVID-19 pandemic. Currently, those restrictions have been lifted by Governor Andy Beshear.
3. EKPC would agree to abide by any safety precautions the Commission may Order for a hearing to be conducted in person.
4. In order to timely publish hearing notice, EKPC respectfully requests the Commission to rule upon this motion on or before July 16, 2021.

WHEREFORE, EKPC respectfully requests the Commission to conduct the August 3<sup>rd</sup> through August 5<sup>th</sup> hearing in person instead of by video conference.
