**JOINT MOTION TO AMEND PROCEDURAL SCHEDULE OF  
THE ATTORNEY GENERAL AND  
NUCOR STEEL GALLATIN**

---

On April 13, 2021, the Kentucky Public Service Commission issued an Order setting a procedural schedule in the above-captioned docket. The Attorney General of the Commonwealth of Kentucky, through his Office of Rate Intervention (“AG”) and Nucor Steel Gallatin (“Nucor”), the only intervenors in this proceeding, respectfully move to amend the procedural schedule in order to allow for more time for parties to draft testimony after receiving data responses from East Kentucky Power Cooperative Inc. (“EKPC”).

The Commission’s Order, in part, establishes the following schedule:

- Initial requests for information to EKPC 05/14/2021
- EKPC’s responses to initial requests for information 05/28/2021
- Supplemental requests for information to EKPC 06/16/2021
- EKPC responses to supplemental requests 06/28/2021
- Intervenor testimony 07/01/2021

This schedule provides that EKPC’s responses to supplemental data requests are due June 28 and that intervenor testimony is then due only three days later, on July 1. The schedule also gives the parties 19 days between receiving EKPC’s initial data responses (May 28) and the due date for supplemental

requests (June 16). The AG and Nucor do not need 19 days to prepare and file supplemental data requests, but will need more than three days to prepare testimony after receiving EKPC's responses.

The AG and Nucor respectfully move that the procedural schedule be amended so that supplemental requests for information to EKPC are due June 4 (instead of June 16) and EKPC responses are due June 16 (instead of June 28). This would give EKPC the same twelve days to prepare its answers. Everything else in the schedule would remain the same. Counsel for EKPC has stated that they have no objection to this change.

The AG and Nucor's proposed schedule is summarized below (proposed amendments in bold):

- Initial requests for information to EKPC 05/14/2021
- EKPC's responses to initial requests for information 05/28/2021
- **Supplemental requests for information to EKPC 06/04/2021**
- **EKPC responses to supplemental requests 06/16/2021**
- Intervenor testimony 07/01/2021
