NOTICE OF WITNESS SUBSTITUTION

Michael Stanton, BayWa r.e. Solar Projects LLC (“BayWa”), and Ms. Andrea Parra, BayWa, will appear at the hearing in place of Clay Canning, who was formerly the project manager of the Bluebird Solar Project.

Mr. Stanton is currently the Senior Vice President of Development for BayWa. He will be assuming responsibility for the following responses that Mr. Canning sponsored: Items 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 28, and 32 of the Responses to the First Request for Information.

Ms. Parra is currently a project engineer at BayWa. Her involvement with the Project will allow her to competently testify regarding the engineering and design requirements for the Project. She will assume responsibility for Mr. Canning’s written responses to the following requests for information: Items 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 29, 30, 31, and 39 of the Responses to the first Request for Information.

Mr. James Cox, construction manager of the Bluebird Solar Project, sponsored a response to Item 37 of the Responses to the first Request for Information. Mr. Cox is expected to begin his paternity leave at the beginning of June 2022. Should Mr. Cox be unavailable to testify at the hearing, Mr. Stanton will appear at the hearing instead of Mr. Cox, and Mr. Stanton will be able to provide competent testimony regarding Mr. Cox's written submission and other construction related matters at the hearing.

Finally, Jeremy Jackson, President of the Jackson Group, will appear in lieu of hane Roberts at the hearing. Mr. Roberts, formerly with the Jackson Group, sponsored responses to the Siting Board's Requests for Information. Mr. Jackson is competent to testify at the hearing regarding environmental matters related to the Project, including the written responses to requests for information that Mr. Roberts submitted: Items 33, 34, 35, and 38 f the Responses to the first Request for Information.
