TO HARRISON FISCAL COURT**

As a reply to the Response of Harrison Fiscal Court to Bluebird Solar LLC’s (“Bluebird Solar”) Motion for Approval of Transfer of Ownership and Control, Bluebird Solar emphasizes its desire to work collaboratively with Harrison County. Representatives of Bluebird Solar have communicated with County officials throughout the development process and will continue to do so.
