

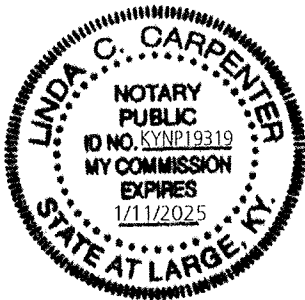

PUBLIC NOTICE - WHITLEY COUNTY WATER DISTRICT NO. 1
PURCHASED WATER ADJUSTMENT

Due to increases in the wholesale rate for water purchased from the McCreary County Water District, Whitley County Water District No.1 (District) has applied to the Kentucky Public Service Commission for a rate increase to cover its increased costs. The rates contained herein are the rates proposed by the District for all customers, however the Public Service Commission may order rates to be charged that are higher or lower than the rates proposed in this notice. Any corporation, association, body public or person may request leave to intervene by motion within thirty (30) days after notice of the proposed rates change is given. A motion to intervene shall be in writing, shall be submitted to the Executive Director, Kentucky Public Service Commission, 211 Sower Boulevard, P. O. Box 615, Frankfort, KY 40602, and shall set forth the grounds for the motion including the status and interest of the party. The application may be reviewed at the District's office at 19 US Highway 25W South, Williamsburg, KY 40769 and the Kentucky Public Service Commission office listed above Monday through Friday, 8:00 a.m. to 4:30 p.m., or through the Commission's website at <http://psc.ky.gov>

The proposed rates are scheduled to go into effect with the May 2021 meter readings which will be reflected on the first billing following June 1, 2021. The proposed rate increase of \$0.21/1,000 gallons or \$0.97 on the average monthly bill will compensate for the higher wholesale purchase water rate implemented by the McCreary County Water District.

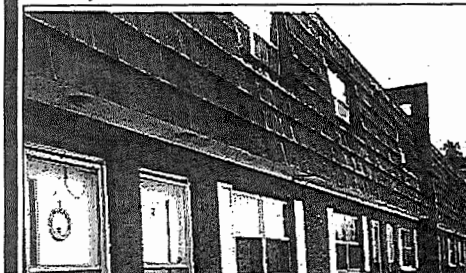
