

The proposed rates are scheduled to go into effect with the May 2021 meter readings which will be reflected on the first billing following June 1, 2021. The proposed rate increase of \$0.21/1,000 gallons or \$0.97 on the average monthly bill will compensate for the higher wholesale purchase water rate implemented by the McCreary County Water District.
