### **APPLICATION**

Pursuant to KRS 74.020(6) and (9), Estill County Water District No. 1 ("Estill District") and Daniel Blain Click (collectively "the Applicants") apply to the Public Service Commission ("Commission") for an Order authorizing a six-month extension of time, until June 30, 2021 for Commissioner Click to complete the required water district management training necessary to qualify for the maximum annual salary of six thousand dollars (\$6,000.00) for the calendar year ending December 31, 2020.

In support of its Application, the Applicants states:

- 1. The full name and post office address of Estill District is: Estill County Water District No. 1, 76 Cedar Grove Road, Irvine, Kentucky 40336. Its e-mail address is: a.miller@estillcountywater.com.
- 2. Commissioner Click's full name and post office address is: Daniel Blain Click, 76 Cedar Grove Road, Irvine, Kentucky 40336. His e-mail address is: blainclick65@gmail.com.

- 4. Estill District not a corporation, limited liability company or limited partnership. It has no articles of incorporation or partnership agreements.
  - 5. Estill District is a water district created under the provisions of KRS Chapter 74.
  - 6. KRS 365.015 does not require Estill District to file a certificate of assumed name.
- 7. Commissioner Click is the chair of Estill District's Board of Commissioners. He was initially appointed as a commissioner on April 5, 2018 to complete his predecessor's unexpired term. On February 15, 2021, the Estill County Judge Executive reappointed Commissioner Click to a term ending February 19, 2025 and Estill County Fiscal Court approved the appointment. The minutes of the Estill County Fiscal Court meetings in which these appointments were announced and approved are attached to this Application as **Exhibit 1** and **Exhibit 2** respectively.
- 8. Pursuant to KRS 74.020(6), Estill County Fiscal Court has established an annual salary of \$3,600 for each member of Estill District's Board of Commissioners and has further

authorized an annual salary of \$6,000 for any commissioner that completes during an educational year a minimum of six instructional hours of water district management training approved by the Public Service Commission. A copy of the minutes of the Estill County Fiscal Court meetings in which these authorizations were issued are attached to this Application as **Exhibit 3** and **Exhibit 4**.

- 9. KRS 74.020(6) provides that "[a]n educational year shall begin on January 1 and end on the following December 31."
- 10. Because the COVID-19 pandemic severely limited potential training opportunities, Commissioner Click was unable to complete a minimum of six approved instructional hours of water district management training.
- During its 2021 Regular Session, the Kentucky General Assembly enacted House Bill 393, which authorizes the Public Service Commission to grant a reasonable extension of time, not to exceed six months, for completing the training requirements of KRS 74.020(6) for good cause shown. Pursuant to the terms of the Act, House Bill 393 took effect upon Governor Beshear's approval on March 18, 2021.
- 12. The Applicants request that the Public Service Commission grant Commissioner Click an extension of time until June 30, 2021 to complete six instructional hours of water district management training approved by the Public Service Commission for the educational year ending December 31, 2020.
- 13. Commissioner Click acknowledges that, if granted the requested extension, his completion of any instructional hours of water district management training in 2021 to be credited for the 2020 educational year may not be used to qualify for an annual salary of \$6,000 for the **2021 educational year** and that he must complete an additional six instructional hours of water

district management training in 2021 to qualify for such salary for the educational year ending December 31, 2021.

WHEREFORE, the Applicants request that the Public Service Commission

- 1. Place this Application at the head of the Commission's docket;
- 2. Issue an Order extending the time in which Commissioner Click must complete six instructional hours of water district management training to qualify for the maximum annual salary of \$6,000 for the year ending December 31, 2020;
- 3. Enter an Order granting the requested relief without holding an evidentiary hearing in this matter and no later **than May 15, 2021**; and,
  - 4. Grant all such other relief to which Applicants may be entitled.

Judge Watson stated that he really likes Tommy (Tommy Mullen former Animal Shelter Supervisor) and he doesn't want to do this but in order to clear and clarify things up he must. The first thing that came up was he was putting his time down from 8am to 4pm working at the Animal Shelter. He was driving the school bus from 2pm to 4pm. He was double dipping. Judge Watson refused to pay him when he was working somewhere else. Another issue came up with picking up dogs. Judge Watson told Mr. Mullen not to be picking up dogs in the county or in the city if they were not bothering anybody. If the dog is just out running around Judge Watson did not want to have the Animal Control Officer out picking up dogs just to be picking them up. We try to work with the people and help people out. If there is a vicious dog or one that is bothering someone that is different. There was an issue of Tik Tok Videos. This was brought to Judge Watson's attention by more than one person. Mr. Mullen was making videos at the Animal Shelter and they were not nice videos. He was on duty when he made them and they were being made in the Animal Shelter office. It continued and Judge Watson talked to him about it. The next issue was with a piece of County Equipment, a Back Hoe, that was safely parked at Harg's grocery store over a weekend. It was close to the business where no one would bother it. Mr. Mullen was caught bringing the Back Hoe back. He had taken the Back Hoe to his home and this is not permissible. Mr. Mullen had also sent a sexual video to a Co-Worker. Judge Watson brought him in and talked to him about it and suspended him for 2 weeks. Mr. Mullen said in a video or on FACEBOOK that Judge Watson tried to get him to tell people that he was out on vacation. Judge Watson said he did not tell him that.
