Mr. Dozier,

The Kentucky Public Service Commission has scheduled Columbia's Rate Case Hearing for November 3-5, 2021. We would like to work with AdOhio for publication of the required Public Hearing Notice. The Public Notice will be published in each newspaper one time. We discussed this briefly back in May and you provided the attached information. We will need to confirm the 9 notice sizes as an additional sentence (highlighted below) will be added to the existing verbiage.

Publication of the notice in the newspapers must be no earlier than Wed. Oct. 13 and no later than Wed. Oct. 27. Does Columbia need to provide you a Pdf form of the notice or will a Word doc be sufficient?
