MOTION FOR DEVIATION

Comes now Columbia Gas of Kentucky, Inc., ("Columbia"), by counsel, pursuant to 807 KAR 5:001 Section 15, 807 KAR 5:001 Section 22 and other applicable law, and for its Motion requesting that the Kentucky Public Service Commission ("Commission") grant a deviation from 807 KAR 5:001 Section 15(2)(d)2., respectfully states as follows:

1. Columbia filed its Notice of Intent and its Election to Use Electronic Filing

Procedures in this matter on April 28, 2021.

2. Columbia is filing its Application in this matter contemporaneously with this Motion.

3. As part of the Application, Columbia is requesting a Certificate of Public Convenience and Necessity ("CPCN") to authorize Columbia to renovate its existing Lexington headquarters and to construct small structures in order to install and operate a new safety training facility for its employees.

4. The safety training facility will enable Columbia to have a training facility for its employees without requiring employees to travel to other states to obtain needed training.

5. Columbia has not yet developed detailed engineering plans and specifications and therefore is unable to provide these to the Commission in accordance with the regulation at this time. The proposed facility will be self-contained within the existing footprint of the Company's headquarters in Lexington and will not impact the service of other utilities or result in any wasteful duplication of service. Accordingly, Columbia requests a deviation from this requirement in the Application filing.

 Columbia will provide detailed engineering plans and specifications to the Commission once they are available.

WHEREFORE, on the basis of the foregoing, Columbia respectfully requests the Commission to grant a deviation from 807 KAR 5:001, Section 15(2)(d)2. with regard to filing detailed engineering plans and specifications.
