**ATTORNEY GENERAL’S MOTION FOR PARTIAL ENLARGEMENT OF TIME  
TO FILE CERTAIN SUPPLEMENTAL DATA REQUESTS**

The intervenor, the Attorney General of the Commonwealth of Kentucky, through his Office of Rate Intervention (“OAG”), hereby moves the Commission for a partial enlargement of time within which to file a certain supplemental data request.

In support of this motion, counsel states that OAG has been working with counsel for Columbia Gas of Kentucky, Inc. (“Columbia Kentucky”) to clarify certain of Columbia Kentucky’s responses to the OAG’s initial data requests. The two parties have reached agreement on all issues pertaining to such responses. However, the Columbia Kentucky witness responsible for providing an amended response to OAG DR 1-197 has been out of the office, and will not be able to provide such an amended response until after the August 11, 2021 deadline for filing of supplemental data requests has passed.

In order to provide Columbia Kentucky sufficient time to provide an amended response to OAG DR 1-197, and to provide OAG sufficient time to review that response in order to determine whether he will file any supplemental data requests pertaining to that item, counsel respectfully requests the Commission grant OAG one additional business day following the date that Columbia Kentucky files its amended response to OAG DR 1-197, in which to file any supplemental data requests OAG may have pertaining to Columbia

Kentucky's amended response to this request. Simultaneous with the filing of the instant motion, counsel for OAG is filing all the remaining supplemental data requests on August 11, 2021, that have no bearing on the request at issue. Counsel for Columbia Kentucky has authorized OAG to represent that Columbia Kentucky has no objection to this motion.

WHEREFORE, counsel for OAG respectfully requests that the Commission grant his motion.
