Regarding the change in professional service expense for each year from 2107 through the Base Period, identify the 10 largest vendors with expense balances of \$20,000 or more that are contributing to this change from year-to-year, and explain why these vendors cost changed from year-to-year. Also, provide copies of contracts for these related vendors, a description of the services provided, and a copy of the three largest invoices (for each applicable period) for each vendor.
