On May 14, 2021, the Kentucky Public Service Commission (PSC) accepted for filing Buffalo Trail Water Association, Inc.'s (Buffalo Trail Water) application requesting to increase its revenue from water sales by \$34,186, an approximate increase of 4.66 percent. On August 10, 2021, Buffalo Trail Water amended its application to request an approximate increase in water revenues of 6.22 percent. On September 10, 2021, the PSC recommended an increase of \$94,437 an approximate increase of 12.86 percent. Buffalo Trail Water requests the PSC approve its recommended revenue requirements and that Buffalo Trail Water be allowed to implement the revised rates as follows:
