Pursuant to the Commission's Order of July 8, 2021 in the above-referenced matter, enclosed for filing is Morgan County Water District's s letter and invoice. This letter and the enclosed invoice are true and accurate copies in paper medium of the electronic version of the documents uploaded to the Public Service Commission's Electronic Filing System this day.

Summary of work: We replaced 270 feet 8-inch main water line with a Poly. Added an 8-inch Gate Valve. This was a section of line on HWY 772 and Greasy Creek Road that was leaking under the road and running into the creek. We completed a direction bore with Poly pipe 10 to 12 feet under the road and creek. We estimate that this was leaking around 20,000 gallons of water per day.
