ATTORNEY GENERAL’S MOTION TO AMEND PROCEDURAL SCHEDULE

The intervenor, the Attorney General of the Commonwealth of Kentucky, through his Office of Rate Intervention [“OAG”], hereby moves the Commission to amend its procedural schedule issued on July 23, 2021 in the above-styled case.

In support of this Motion, the OAG states the Commission’s procedural schedule requires initial data requests to be filed by August 5, 2021. The OAG’s expert witness in this matter is currently scheduled to appear at the live hearing scheduled in Case No. 2021-00103¹ for August 3, 2021 through August 5, 2021. Additionally, the OAG has also retained this same witness in Case No. 2021-00190,² in which supplemental data requests are due to be filed no later than August 4, 2021. The OAG’s expert witness is unable to complete all three such deadlines unless the Commission grants an extension of time to file initial data requests in the above-styled case.

The OAG and counsel for Atmos Energy Corporation [“Atmos”] agree that changing the currently scheduled respective due dates for filing initial requests and responses thereto from August 5th and August 19th to August 9th for the filing of such requests, and August 23rd for filing responses thereto, is acceptable to both parties, with all other dates remaining unchanged.
