PROPOSED WATER RATE INCREASE

The rates contained in this notice are the rates proposed by **MADISON COUNTY UTILITY DISTRICT** for all customers regardless of classification. However, the Public Service Commission may order rates to be charged that differ from these proposed rates. Such action may result in rates for consumers other than the rates in this notice. The proposed rates will be filed with the Kentucky Public Service Commission no later than May 7th, 2021.

Any Corporation, association, body politic or person may examine the rate increase application at the offices of the Public Services Commission's office at 211 Sower Boulevard, Frankfort, KY Monday-Friday 8 a.m.-4:30 p.m. or through the Commission's website at <http://psc.ky.gov>. During Covid-19 restrictions, inspections may be limited to online inspections only. Any Corporation, association, body politic or person may by motion within thirty (30) days after publication or mailing of notice of the proposed rate changes request leave to intervene. If the Commission does not receive a written request for intervention within 30 days of initial publication or mailing of the notice, the Commission may take final action on the application. Comments regarding the application may be submitted to the Commission through the Commission's website or via mail at Public Service Commission, P.O. Box 615, Frankfort, KY 40602. The motion to implement the proposed rates shall be submitted to the Public Service Commission, 211 Sower Boulevard, P.O. Box 615, Frankfort, KY 40602. Anyone may obtain copies of the application and testimony by contacting **MADISON COUNTY UTILITIES** where they will also be available for public inspection at 297 Michelle Drive, Richmond, Kentucky 40475.
