Re: Logan County Solar Farm Notice of Application

Dear Neighbor:

This letter is to inform you that Russellville Solar, LLC is proposing to construct and operate a 173-megawatt AC solar photovoltaic facility adjacent to your property in Logan County. The approximate street address of the proposed Solar Project is 1602 Watermelon Rd, Olmstead, KY 42265, and the latitude and longitude are: 36.78220206864482, -86.94351648327084 in Logan County, Kentucky. It is bounded on the west by Watermelon Road and the Memphis and Ohio Railroad, which roughly parallels US Highway 79 approximately ¼ mile south of the highway. Joe Montgomery Road traverses eastern portions of the project site. The proposed facility and its applicants previously hosted public meetings about the project on July 23, 2021 and December 14, 2021 at the Logan County Extension Services Office at 255 John Paul Rd, Russellville, KY 42276.

The proposed Logan County Solar Farm will be sited on up to 1,569 acres of land and consist of solar photovoltaic panels and associated racking, 260 inverters, battery storage and a project substation transformer. Russellville Solar LLC is required to file an application for construction and operation of the proposed facility. This application is subject to the approval of the Kentucky State Siting Board on Electric Generation and Transmission Siting, which can be reached at P.O. Box 615, 211 Sower Boulevard, Frankfort, Kentucky 40602-0615, or via phone at (502) 564-3940.

A person who wishes to become a party to a proceeding before the board may, by written motion filed no later than thirty (30) days after the application has been submitted, request leave to intervene. A party may, upon written motion filed no later than thirty (30) days after an application has been filed, request the board to schedule an evidentiary hearing at the offices of the Public Service Commission, 211 Sower Boulevard, Frankfort, Kentucky 40602-0615.

A request for a local public hearing or local public information meeting shall be made by at least three (3) interested persons who reside in the county or municipal corporation in which the pipeline, plant, or transmission line is proposed to be located. The request shall be made in writing and shall be filed within thirty (30) days following the filing of a completed application. Free legal services, counseling available to tornado survivors

If you are facing new legal issues or experiencing feelings of hopelessness or stress as a result of the Dec. 10-11 tornadoes, you can now get free legal advice and free crisis counseling.

FEMA has made the free help available to residents of the 16 counties most affected by the tornadoes: Barren, Caldwell, Christian, Fulton, Graves, Hart, Hickman, Hopkins, Logan, Lyon, Marion, Marshall, Muhlenberg, Ohio, Taylor and Warren.

Free Legal Services. Low-income, elderly and other vulnerable residents who were affected by the disaster and are unable to afford their own lawyer may call 877-782-4219. The helpline is open 9 a.m. to 3 p.m. Monday to Friday. Voice-mail messages can be left 24 hours a day, every day.

When leaving a message, include the county where you are located and describe your tornado-related legal problem. Callers may receive assistance from staff at



Kentucky Legal Aid or a volunteer attorney. Examples of available assistance include help with securing FEMA and other benefits; insurance claims; home repair contracts and contractors; consumer protection matters; replacement of wills and other important legal documents that were destroyed; and mortgage-foreclosure and landlord/tenant problems.

The service is a partnership between FEMA, the American Bar Association Young Lawyers Division, the Kentucky Bar Association and other Kentucky legal groups.

Immediate Crisis

Counseling. The U.S. Department of Health and Human Services and FEMA have activated a Disaster Distress Helpline in Kentucky; telephone or text 800-985-5990. This free crisis support service is available all day every day for disaster survivors experiencing emotional distress or mental health problems caused or aggravated by the tornadoes or their aftermath.

The helpline staff may provide confidential counseling and other needed support services or immediately connect callers to trained professionals from the nearest participating crisis counseling center.

Spanish-speakers can press "2" for bilingual support. Callers can connect with counselors in more than 100 other languages via third-party interpretation services by indicating their preferred language to the responding counselor. A video-phone option for American Sign Language users is also available by calling 800-985-5990 from a video-phone-enabled device or via an "ASL Now" link at samhsa.gov/find-help/disaster-distress-helpline.

FEMA extends application deadline to March 13

Homeowners and renters with uninsured or underinsured damage to their property from the Dec. 10-11 tornadoes in Barren, Caldwell, Christian, Fulton, Graves, Hart, Hickman, Hopkins, Logan, Lyon, Marion, Marshall, Muhlenberg, Ohio, Taylor and Warren counties have another month to apply for FEMA disaster assistance.

FEMA has extended its application deadline to Sunday, March 13. Those who have already applied to FEMA for their Dec. 10-11 tornado damage need not apply again.

FEMA disaster assistance is not a substitute for insurance and cannot compensate for all losses caused by the tornadoes. The assistance is intended to meet basic needs and supplement disaster recovery efforts.

Survivors are encouraged to file insurance claims for damage to their homes, personal property and vehicles before they apply for FEMA assistance.

To apply, visit DisasterAssistance.gov, use the FEMA mobile app or call the FEMA Helpline at 800-621-3362. If

you use a relay service such as video relay service (VRS) or captioned telephone service, give FEMA the number for that service. Helpline operators are available from 6 a.m. to 10 p.m. CST daily. Press 2 for Spanish. Press 3 for an interpreter who speaks your language.




