**APPLICATION TO CONSTRUCT
MERCHANT ELECTRIC GENERATING FACILITY**

Pursuant to KRS 278.706, KRS 278.714 and 807 KAR 5:110, Russellville Solar LLC (“Russellville Solar”), by counsel, submits this application for a construction certificate to construct a merchant electric generating facility. In support of this application, Russellville Solar states as follows:

1. Russellville Solar is a limited liability company organized under the laws of Delaware with a principal place of business of 222 Second Avenue South, Suite 1900 Nashville, TN 37201. Russellville Solar’s phone number is (615) 577-4786. A copy of Russellville Solar’s Certificate of Authority that is on file with the Kentucky Secretary of State’s office is submitted as Attachment I below.
2. The proposed Russellville Solar Facility will be a 173-megawatt alternating current (MWac) photovoltaic electricity generation facility. The project is to be located in Logan County, located at 1602 Watermelon Rd, Olmstead, KY 42265, and the latitude and longitude are: 36.78220206864482. -86.94351648327084 It is bounded on the west by Watermelon Road

and the Memphis and Ohio Railroad, which roughly parallels US Highway 79 approximately ¼ mile south of the highway. Joe Montgomery Road traverses eastern portions of the project site.

3. Pursuant to KRS 278.706, 278.714, and 807 KAR 5:100, Russellville Solar is submitting its application fee of with this filing.
