JOINT MOTION TO SUSPEND PROCEDURAL SCHEDULE

East Logan Water District and Logan Telephone Cooperative, Inc. ("Movants" or "Parties") jointly move to suspend the procedural schedule set forth in the Order of October 6, 2023 ("the Order") until such time as the Movants have filed a settlement agreement in this matter and the Public Service Commission ("Commission") has reviewed such agreement. In support of their motion, the Movants state:

- 1. On October 6, 2023, the Commission issued an order setting this matter for hearing on December 19, 2023 and directing each party to file a list of witnesses expected to testify on its behalf and a summary of each witness's expected testimony.
- 2. Since the issuance of the Order of October 6, 2023, the Parties have engaged in discussions to resolve this matter and have recently reached an agreement in principle. The Parties believe that their agreement represents a fair and reasonable resolution of their dispute. They are currently reducing this agreement to writing and will submit the written agreement to the Commission no later than December 11, 2023 with a request that the Commission review and approve such agreement and declare the Complaint in this matter to be satisfied.

- 3. Suspending the procedural schedule will permit the Parties sufficient time to complete and submit the written agreement and the Public Service Commission adequate time to review that agreement. Moreover, it will allow the Parties and the Public Service Commission to avoid the expenditure of time and resources for a hearing that has been rendered unnecessary as a result of the Parties' agreement.
 - 4. This motion is made in good faith and not for purposes of delay.

WHEREFORE, the Movants request that the procedural schedule in this matter be suspended until further notice and that they be permitted until December 11, 2023, to file their written agreement with the Commission and a motion for Commission approval of that agreement and for an order declaring the Complaint in this matter as satisfied.
