Isaac Myers a Governor's representative introduced himself to the new court members and told the court about the upcoming Local Issues Conference.

Joe Plunk District Engineer with the Kentucky Transportation Cabinet addressed the court. He told the court that they are going to implement a restricted U-turn at the intersection of highway 68/80 and highway 73, by South Union. He explained to the court how it works and showed a video of one working on a similar turn in Indiana. Concerns about the project were expressed, with Magistrate Robert Chyle stating that several people don't like the plan.

Chris Killenberg with Community Energy Solar addressed the court. He told the court that they looking into putting a large scale solar farm in Logan County, presenting proposed images. According to state regulations a 1,000 ft. setback from structures is required, which would not work for the proposed solar farm. Logan County can create their own setback Ordinance, which would override state regulations. After much discussion it was decided that County Attorney Joe Ross would create an Ordinance, which would require that the fence around the solar farm would have to be 250 ft. from existing structures and cemeteries, 100 ft. from any road right-away and 100 ft. from property lines (unless property owner signs a waiver).

Sheriff Stephan Stratton told the court that they have been watching the Stevenson Mill Road area for the last couple of weeks, but haven't caught anyone speeding.

Jailer Phil Gregory reported that there are currently 221 total inmates, with 139 being state prisoners.

Nathan Cockrill Solid Waste Coordinator presented the Recycling Center materials report for 7/8/19 thru 7/22/19. He told the court that the household hazardous waste day is scheduled for October 4<sup>th</sup>, with the court agreeing to have it in the gravel lot by the Extension Office.

Ernie Ezell addressed the court, expressing some concerns about changing regulations to accommodate proposed solar farms. He told the court that court members need to look at an actual installation before making a decision.

There was a discussion about areas in the county which do not get internet service.

Solid Waste Coordinator Nathan Cockrill presented a June 2020 road litter pickup report, along with a Recycling Center report from June 9<sup>th</sup> thru July 13<sup>th</sup>.

Magistrate Thomas Bouldin informed the court about the common ground meeting held last week regarding building permits and contractor licensing. He told the court that he believed Fiscal Court is the responsible party for a subdivision ordinance, which is from 1997. There was much discussion about private roads that have been put in which are not in compliance.
