2:40 – 3:40 PSC Regulation of Municipal Utility Wholesale Rates: What You Don't Know Can Hurt You (Part 1)

Gerald Wuetcher, Stoll Keenon Ogden

While the Public Service Commission has regulated the wholesale rates that municipal utilities charge to PSC-regulated utilities for 20 years, recently it has become more aggressive, investigating proposed increases in wholesale rate that in earlier years would have been routinely accepted. This presentation examines the history of PSC regulation of municipal water utility wholesale rates, with an emphasis on recent regulatory trends. It discusses approaches to lessen the likelihood of a rate review, provides an overview of PSC procedures for such reviews, and identifies the most common issues that arise in those reviews. Presenter will examine tactics that a city can employ to defend its proposed rate increase and obtain a favorable result. He will also examine how PSC-regulated utilities can use PSC proceedings to effectively oppose or mitigate wholesale rate increases.
