EXHIBIT A

NOTICE

On or about September 23, 2021, McCreary County Water District will file applications with the Kentucky Public Service Commission for the purpose of adjusting its monthly rates for water and sewer service. McCreary County Water District is making these applications to comply with the Kentucky Public Service Commission's Order of June 26, 2020 in Case No. 2020-00151 and Order of February 22, 2021 in Case No. 2021-00021. Under the methodology the Public Service Commission uses to establish rates for utility service, McCreary County Water District should increase its rates for water service approximately 8.70 percent and its rates for sewer service approximately 49.13 percent. Because of recent increases in water rates and expected increases to be phased in over one or more years.

McCreary County Water District's applications will be filed pursuant to the procedures set forth in 807 KAR 5:076. Under those procedures, the proposed rates may not be placed into effect until the Kentucky Public Service Commission has issued an order approving the proposed rates or six (6) months from the date of the filing of the application, whichever occurs first.

McCreary County Water District proposes to adjust its rates for monthly water service in two phases. Phase 1 rates will become effective upon the Kentucky Public Service Commission's approval. Phase 2 rates will become effective one year later. The proposed rates for water service are as follows:

If the Public Service Commission approves the proposed sewer rates, the Phase 1 monthly bill for a customer who uses 4,000 gallons of water will increase from \$41.07 to \$43.31, or 5.45 percent. The Phase 2 monthly bill for that customer will increase from \$43.31 to \$45.55 or 5.17 percent. When the Phase 3 rates take effect, that customer's bill will increase from \$45.55 to \$47.79 or 4.92 percent. The Phase 1 monthly bill for U.S. Penitentiary-McCreary, which produces an average of 5,605,575 gallons of wastewater monthly, will increase from \$46,042.18 to \$48,552.35, or 5.45 percent. Its monthly bill will increase to \$51,062.89 or 5.17 percent when Phase 2 rates take effect and to \$53,572.67 or 4.92 percent when Phase 3 rates become effective.

The Kentucky Public Service Commission has established Cases No. 2021-00300 (Sewer) and No. 2021-00301 (Water) to review McCreary County Water District's applications. Any person may examine these applications at McCreary County Water District's office, 456 N. Highway 27, Whitley City, Kentucky 42653 or at the Kentucky Public Service Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky, Monday through Friday, 8:00 a.m. to 4:30 p.m., or through the Public Service Commission's Web site at https://psc.ky.gov/Case/ViewCaseFilings/2021-300 (Sewer) or https://psc.ky.gov/Case/ViewCaseFilings/2021-301 (Water).

Comments regarding either application may be submitted to the Kentucky Public Service Commission through the Commission's Web Site at http://psc.ky.gov or by e-mail to psc.info@ky.gov or by mail to the Public Service Commission, P.O. Box 615, Frankfort, Kentucky 40602.

The rates contained in this notice are the rates proposed by McCreary County Water District. However, the Kentucky Public Service Commission may order rates to be charged that differ from the proposed rates. Such action may result in rates for consumers other than the rates in this notice.

A person may submit a timely written request for intervention to the Kentucky Public Service Commission, P.O. Box 615, Frankfort, Kentucky 40602, establishing the grounds for the request including the person's status and interest. If the Kentucky Public Service Commission does not receive a written request for intervention within thirty (30) days of the initial publication of notice, it may take final action on the proposed rates.
