PETITION FOR REHEARING

Pursuant to KRS 278.400, Alan Fox, Arne Puckett, William Gillahan, James Schade, Terry Teitloff and Micah Joiner¹ ("Intervening Petitioners") and Ledbetter Water District ("Ledbetter District") petition for rehearing of the Public Service Commission's ("Commission") Order of May 13, 2022 in this matter.

Neither Ledbetter Water District nor Intervening Petitioners are contesting the civil penalties assessed or the refund directed by the Order of May 13, 2022. While Ledbetter District and the Intervening Petitioners respectfully disagree with the Commission's determination that Ledbetter District **willfully violated** KRS 278.160, they acknowledge that a violation of KRS 278.160 occurred, that this violation was directly related to a lack of knowledge and understanding on the part of Ledbetter District officials of the laws critical to Ledbetter District's operation as a public utility, and that this lack of knowledge represents a significant departure from acceptable standards and a failure on the part of these officials to meet their legal and moral responsibilities to the Ledbetter District.

Ledbetter District and the Intervening Petitioners respectfully submit that modifications to the Order of May 13, 2022 are required to correct ambiguities in the Order, to protect persons who were not involved in the decisions related to the assessment of unauthorized rates, and to ensure a more efficient and effective refund of improperly collected monies. More specifically, they request that the Order of May 13, 2022 be amended (1) to identify by name the persons who are subject to a penalty for Ledbetter District's failure to comply with KRS 278.160 and to expressly exclude Micah Joiner from the assessment of any civil penalty; (2) to clarify that the assessed penalty is suspended until March 31, 2023 and will be vacated if the assessed person, completes six hours of certified water management training by March 31, 2023; (3) to remove or otherwise clarify the requirements set forth in ordering paragraphs 2 and 3 of the Order of May 13, 2022; and (4) to base the required refund credit upon Ledbetter District's current number of customers (1,268) rather than the number of customers that existed on December 31, 2020.

Identity of Penalized Officials. The Order of May 13, 2022 does not identify by name the Ledbetter District officials assessed the penalty of \$250. Similarly, Order of August 5, 2021, which initiating this matter, does not identify any Ledbetter District official by name against whom the assessment of a penalty was being considered. As a result, it is unclear who has been assessed a penalty – those who are currently on Ledbetter District's Board of Commissioners or those members of the Board of Commissioners who approved the assessment of unauthorized rates.

Micah Joiner, a current member of Ledbetter District's Board of Commissioners, became a member of the Board of Commissioners on March 16, 2021 when the term of his predecessor Phillip Dae expired. There is no evidence in the record to support a finding that Mr. Joiner aided or abetted the assessment of unauthorized rates or that he had any knowledge of the general manager's lack of knowledge of utility law and Commission procedures. He was not a

commissioner on May 19, 2020 when the Board of Commissioners authorized an increase to Ledbetter District's rates to passthrough an increase in the rates of the water district's water supplier. He did not begin attending Board meetings until March 2021, just shortly before Ledbetter District ceased assessing the unauthorized rates. While he briefly served on the Board of Commissioners when Ledbetter District charged unauthorized rates, Mr. Joiner was never in a position to prevent the initial assessment of the unauthorized rates, to supervise or oversee the general manager's attempts to prepare and submit the May 2020 application for rate adjustment or to affect the general manager's training prior to March 2021.²

Clarification of the Penalty's Effective Date. The Order of May 13, 2022 provides that the assessed penalties are "suspended for one year *conditioned upon* Ledbetter District's commissioners and manager attending six hours of certified water management training by March 31, 2023."³ Based upon a literal reading of the Order, the assessed penalties are currently in effect and can be enforced at any time against any Intervening Petitioner until he completes the required training. Upon completion of that training, the penalties are then suspended for one year. The penalties are not vacated, only suspending. The obligation to pay the assessed penalty continues and can be enforced at the end of the one-year suspension period.

The Order of May 13, 2022 departs from the previous Commission practice that was intended to encourage remedial actions by utilities or utility officials assessed civil penalties for violations of KRS Chapter 278. Previously, the Commission in an order assessing a civil penalty

against a utility official would suspended the penalty's effective date to allow the offending official time to perform the remedial action and would provide for the penalty to be vacated without further order if the remedial training was timely completed and of evidence of that completion was presented.⁴

Ledbetter District and Intervening Petitioners respectfully submit that the Order be amended to state that the penalties are suspended as of May 13, 2022 for a period of one year and, if the required training is performed by March 31, 2023, vacated without further order. Neither Ledbetter District nor Intervening Petitioners object to the assessed penalty for any Intervening Petitioner becoming immediately due and payable if the Intervening Petitioner fails to comply with the provisions of the Order of May 13, 2022.

Ordering Paragraph 2. The Order of May 13, 2022 directs that "Ledbetter District's commissioners and manager shall attend six hours of certified water management training by March 31, 2023." This provision is separate from and in addition to the first ordering paragraph that assesses a penalty against Ledbetter District's general manager and commissioners. Read together, these paragraphs suggest that penalty assessed against the general manager and commissioners is a \$250 penalty **and mandatory attendance at six hours of certified water management training.**

While the first ordering paragraph states attendance at certified water management training will substitute for the penalty of \$250 and offers an incentive to Ledbetter District's general manager and commissioners to voluntarily attend certified water management training, the second ordering paragraph imposes a mandatory duty to attend six hours without regard to payment of any penalty or attendance at certified water management training. Hence, if the general manager

or a commissioner wishes to avoid any penalty, they must attend **twelve hours** of certified management training. This interpretation is supported by the third ordering paragraph, which requires Ledbetter District's "commissioners and manager . . . file written notice no later than May 1, 2023, that they attended six hours of certified water management training by March 31, 2023." This paragraph also is not expressly conditioned upon the general manager or a commissioner electing not to pay the assessed penalty.

Intervening Petitioners request the Commission address the ambiguities presented by the second and third ordering paragraphs and expressly state whether the second ordering paragraph imposes a separate duty, in addition to the payment of a penalty, to attend certified water management training, or is intended merely to implement the alternative sanction imposed by the first ordering paragraph.

Amount of the Refund Credit. The Order of May 13, 2022 requires all excess monies be refunded over a six-month period and specifies a monthly refund credit of \$1.11. The monthly credit amount was derived by dividing the total amount of excess monies by the number of Ledbetter District customers as of December 31, 2020.⁵ As of December 31, 2020, Ledbetter District had 1,200 customers. It currently has 1,268 customers.⁶ Ledbetter District respectfully requests that a monthly credit amount be based upon the current number of customers rather than the number of customers on December 31, 2020 and that a monthly refund credit of \$1.05 be authorized instead. A credit of \$1.05 will result in a more precise refund of funds and significantly reduce the need for any billing adjustments at the end of the refund period.

WHEREFORE, Ledbetter District and Intervening Petitioners respectfully request that the Public Service Commission grant their Petition for Rehearing and modify the Order of May 13, 2022 to (1) identify by name the persons who are subject to a penalty for Ledbetter District's failure to comply with KRS 278.160 and expressly exclude Micah Joiner from the assessment of any civil penalty; (2) clarify that the assessed penalty is suspended until March 31, 2023 and will be vacated without further order of the Public Service Commission if the assessed person, completes six hours of certified water management training by March 31, 2023; (3) remove or otherwise clarify the requirements set forth in ordering paragraphs 2 and 3 of the Order of May 13, 2022; and (4) base the required refund credit upon Ledbetter District's current number of customers (1,268) rather than the number of customers that existed on December 31, 2020.
