# **RESPONSE TO ORDER OF AUGUST 4, 2021**

Pursuant to the Public Service Commission's ("Commission") Order of August 4, 2021, Ledbetter Water District ("Ledbetter District") responds to the allegations set forth therein as follows:

- 1. Ledbetter District is a water district organized under KRS Chapter 74. Pursuant to KRS 278.015, its rates and service are subject to the Commission's regulation.
- 2. For the period from January 1, 2018 through December 31, 2020, Ledbetter District satisfied its water requirements as shown in Table 1.

All water that Ledbetter District purchases to meet its water requirements is purchased from Crittenden-Livingston Water District ("Crittenden-Livingston District") .

3. On May 23, 2019 in Case No. 2018-00414, the Commission authorized Crittenden-Livingston District to increase its rates in three phases.<sup>1</sup> The first phase of the increase became

effective on May 23, 2019. The second and third phases of the authorized increase were to take effect one year and two years later respectively.

- 4. Following Crittenden-Livingston District's implementation of the first phase of the increase, Ledbetter District applied to the Commission pursuant to 807 KAR 5:068 to increase its rates commensurate with the increase in Crittenden-Livingston District's rates. On July 23, 2019 in Case No. 2019-00196,<sup>2</sup> the Commission authorized an increase in Ledbetter District's rates to reflect the higher cost of purchasing water from Crittenden-Livingston District.
- 5. Ledbetter District's General Manager Billy Downs retired on July 31, 2019. Alan Fox succeeded Mr. Downs. Prior to his selection as general manager, Mr. Fox was employed by Ledbetter District for 14 years to maintain and oversee the operations of Ledbetter District's water treatment plant and water distribution system, as well as Ledbetter District's sewage collection and treatment facilities. He was not involved in Ledbetter District's financial or administrative matters and had no experience dealing with the Commission or with regulatory issues. He had very limited knowledge of the requirements of KRS Chapter 278 or Commission practice or procedure.
- 6. On April 14, 2020, approximately one month prior to Crittenden-Livingston District's required implementation of the second phase of its authorized rates, Mr. Fox requested assistance from the Commission to prepare an application for a purchased water adjustment ("PWA"). He contacted the Commission's public information officer by electronic email. His request for assistance was referred to the Director of the Commission's Financial Analysis Division, who referred the request to Commission Staff member Jason Green. On April 16, 2020,

Mr. Green contacted Mr. Fox by electronic mail to offer his assistance. A copy of this electronic mail traffic is attached to this Response as Exhibit A.

- 7. On April 22, 2020, Mr. Fox sent to Mr. Green by electronic mail Ledbetter District's application for a PWA to reflect the effects of Crittenden-Livingston District's implementation of the second phase rates. He advised Mr. Green that the application was the "first one I have been involved with so let me know if [I] need to do anything else." A copy of this message and the application are attached as Exhibit B.
- 8. Mr. Green responded to the electronic message the same day and advised Mr. Fox that his application "looks good" and that his calculations appear correct. He recommended that the PWA factor in the application, which was calculated at \$0.1581, should be revised to \$0.16 to permit the recovery of "the full amount of the increase in purchased water." *See* Exhibit C.
- 9. On April 25, 2020, Mr. Fox responded to Mr. Green's message and advised him that he would place an advertisement in the local paper to advertise the increase of \$0.16 per 1,000 gallons in Ledbetter District's rate. *See* Exhibit C.
- 10. On May 11, 2020, Mr. Fox sent an electronic mail message to Mr. Green in which he stated: "I am trying to see if there is anything else I need to do for our adjustment. I have listed it in [the] Livingston ledger (sic) paper." A copy of this message is attached as Exhibit D to this Response.
- 11. On May 19, 2021, Ledbetter District's Board of Commissioners approved an adjustment of Ledbetter District's water rates to passthrough the increased purchased water costs resulting from Crittenden-Livingston District's implementation of the second phase rates. This adjustment required the implementation of a purchased water adjustment factor of \$0.16.

- 12. On May 23, 2020, Crittenden-Livingston District implemented the second phase of the authorized increase, increasing its wholesale rate to Ledbetter District from \$2.83 per 1,000 gallons to \$3.08 per 1,000 gallons.
- 13. On May 28, 2020, notice of a \$0.16 per 1,000 gallons increase in Ledbetter District's rates was published in the *Livingston Ledger*. A copy of this notice is attached to this Response as Exhibit E.
- 14. On June 3, 2020, Mr. Fox emailed Mr. Green a copy of Ledbetter District's application with the revised PWA adjustment factor and the published notice. He noted on his message that "[T]his is in regards to [L]edbetter [W]ater [D]istrict[']s purchased water adjustment. [T]hanks for your help." A copy of this message and the application is attached to this Response as Exhibit F. There is no record of any Commission Staff response to this message or any subsequent Commission Staff inquiry regarding this PWA application prior to March 2021.
- 15. Mr. Fox misinterpreted his communications with Commission Staff and his submission of these documents to Commission Staff as constituting the filing of the documents and assumed that no further action was required on Ledbetter District's part, and that Ledbetter District could proceed to charge the new rates. Neither he nor any other Ledbetter District official realized that additional actions were required to file the application for purchased water adjustment and that no official action had been taken on the documents that he submitted.
- 16. The Commission's Order of March 16, 2020 in Case No. 2020-00085<sup>3</sup> added to the Mr. Fox's confusion. In that Order, the Commission discouraged the filing of physical documents by mail and encouraged the use of the Commission's electronic filing system or electronic mail to deliver documents to the Commission. At that time, Ledbetter District had never used the

Commission's electronic filing system to file any documents in a formal proceeding. Mr. Fox was unfamiliar with that system. He mistakenly believed his electronic mailing of documents to Commission Staff satisfied the requirements of the March 16, 2020 Order.

17. From May 23, 2020, until May 4, 2021, Ledbetter District charged the following rates for water service:

Customer Charge: \$7.74 per month First 25,000 gallons \$6.99 per 1,000 gallons

Over 25,000 gallons \$4.83 per 1,000 gallons

18. In anticipation of Crittenden-Livingston District's implementation of third phase rates, Mr. Fox in early March 2021 began preparing an application for a purchased water adjustment to passthrough the increased purchased water costs resulting from the third phase rates. After realizing that no revised tariff sheet reflecting Ledbetter District's current rates had been filed after the submission of the final version of the PWA application, Mr. Fox contacted Commission Staff for assistance. After discussions with Commission Staff, Mr. Fox realized that the earlier application had not been properly filed. Ledbetter District then filed an application for a purchase water adjustment to reflect the increased costs of the implementation of the second phase rates, which was docketed as Case No. 2021-00158.<sup>4</sup> On May 4, 2021, it entered an order approving a purchased water adjustment factor of \$0.15 and following rates for water service effective as of May 4, 2021:

Customer Charge: \$7.74 per month

First 25,000 gallons \$6.98 per 1,000 gallons Over 25,000 gallons \$4.83 per 1,000 gallons

19. Ledbetter District began charging the rates set forth in the Order of May 4, 2021 for service rendered on and after that date.

20. On May 23, 2021, Crittenden-Livingston Water District implemented the third phase of the authorized increase, increasing its wholesale rate to Ledbetter District from \$3.08 per

1,000 gallons to \$3.34 per 1,000 gallons.

On June 15, 2021, Ledbetter District's Board of Commissioners approved an 21.

adjustment of Ledbetter District's water rates to passthrough the increased purchased water costs

resulting from Crittenden-Livingston District's implementation of the third phase rates.

22. On June 25, 2021, Ledbetter District applied to the Commission for a purchased

water adjustment to reflect the increased costs of the implementation of the third phase rates. Its

application was docketed as Case No. 2021-00238.<sup>5</sup> On August 4, 2021, it entered an order

approving a purchased water adjustment factor of \$0.16 and following rates for water service

effective August 4, 2021:

Customer Charge:

\$7.74 per month

First 25,000 gallons

\$7.14 per 1,000 gallons

Over 25,000 gallons \$4.98 per 1,000 gallons

23. Between May 23, 2020, until May 4, 2021, Ledbetter District charged and collected

rates that differed from those on file with the Commission. During this period, Ledbetter District

sold approximately 49,766,787 gallons of water. As a result, Ledbetter District billed and collected

revenues approximately \$7,962.69 greater than the revenues that would have been collected if the

rates in its filed rate schedules had been charged.<sup>6</sup>

24. Ledbetter District failed to comply with KRS 278.160 between May 23, 2020 and

May 4, 2021 by assessing rates for water service that differed from those contained in its filed rate

schedules. However, neither Ledbetter District nor any of its officers or agents willfully or

- 24. Ledbetter District failed to comply with KRS 278.160 between May 23, 2020 and May 4, 2021 by assessing rates for water service that differed from those contained in its filed rate schedules. However, neither Ledbetter District nor any of its officers or agents willfully or intentionally violated KRS 278.160. All acted under a good faith belief that the necessary actions had been taken to adjust Ledbetter District's rates and the rates charged were the proper and lawful rates for water service. Mr. Fox sought the assistance of Commission Staff and attempted to comply with Commission Staff's guidance. He had no prior experience with making filings with the Commission and was unfamiliar with Commission practice and procedure. Moreover, Ledbetter District lacked legal counsel or other advisors that could have assisted Ledbetter District in ensuring proper procedures were follow.
- 25. Ledbetter District did not violate 807 KAR 5:068 as that regulation merely sets forth the procedures necessary for a water district or water association to obtain a purchased water adjustment pursuant to KRS 278.012 and KRS 278.015. The regulation is procedural in nature. Failure to follow that regulation results in rejection of a water district's application for rate adjustment pursuant to that regulation and deprives a water district of the legal authority to adjust its rates pursuant to KRS 278.015. A water district that proceeds to charge rates that differ from its filed rates without properly filing an application for purchased water adjustment violates KRS 278.160 for assessing a rate not set forth in its tariff or otherwise authorized by the Commission.
- 26. Ledbetter District requests permission to retain the amounts collected from May 23, 2020 to May 4, 2021 as these amounts represented the increased cost of purchased water and were remitted to Crittenden-Livingston Water District to cover that increased cost. If the Commission determines that these amounts must be refunded, Ledbetter District respectfully requests that it be

permitted to assess a surcharge over a period of 12 months to collect approximately \$7,962.69 to recover its increased purchased water costs for the period from May 23, 2020 to May 4, 2021. Such surcharges to recover the previously incurred purchased water increases have been found to be reasonable and lawful. *See Kentucky Public Service Commission v. Cumberland Falls Highway District*, 834 S.W.2d 728 (Ky. Ct. App. 1992).

WHEREFORE, Ledbetter District requests that the Commission close its investigation without taking further action against Ledbetter District or its officers or employees.



In this case, the total PWA factor is \$0.1581, so you should round up to \$0.16 so that you recover the full amount of the increase in purchased water. Other than that the application looks good. I assume you do not purchase water from any other suppliers? If so you will need to include all suppliers in the application and their current rate to you.
