**ORDER OF THE CLARK COUNTY FISCAL COURT  
SETTING MAXIMUM SALARIES FOR COMMISSIONERS  
OF THE CLARK COUNTY WATER DISTRICT**

**WHEREAS**, The Clark County Water District is a creation of the Clark County Fiscal Court; and

**WHEREAS**, The Clark County Water District is served by Commissioners who determine and approve the day to day operations of the Clark County Water District and assist in the development and vision of the long term goals and operation of the Clark County Water District; and

**WHEREAS**, Pursuant to KRS 74.020, Water District Commissioners receive an annual salary and KRS 74.020 sets the minimum and maximum parameters for salaries which can be paid to Commissioners; however, the amount of actual salary for the Commissioners for each water district must be set by the County Judge/Executive with the approval of the Fiscal Court; and

**WHEREAS**, The Clark County Judge Executive has determined that the amount of the salary for the Commissioners of the Clark County Water District shall be Three Hundred and NO/100 Dollars (\$300.00) per month for each Clark County Water District Commissioner, unless said Commissioner shall have successfully completed six (6) instructional hours of annual water district management training approved by the Public Service Commission, in which event that Commissioner shall receive a salary in the amount of Five Hundred and NO/100 Dollars (\$500.00) per month;

**NOW, THEREFORE, BE IT ORDERED** by the Clark County Fiscal Court as follows:

**SECTION ONE:** The salary for the Commissioners of the Clark County Water District is set at and shall be the sum of Three Hundred and NO/100 Dollars (\$300.00) per month for each Clark County Water District Commissioner. In the event that a Clark County Water District Commissioner shall have successfully completed six (6) instructional hours of annual water district management training approved by the Public Service Commission, then that Clark County Water District Commissioner shall receive a salary in the amount of Five Hundred and NO/100 Dollars (\$500.00) per month.

**SECTION TWO:** That all previous orders or parts thereof in conflict herewith to the extent of said conflict are hereby repealed.

**SECTION THREE:** This Order shall take effect immediately upon the passage of this Order.

Please accept this letter as notice that I will be resigning from my position as commissioner of East Clark County Water Board due to health issues. My last day will be December 31, 2019.


Thank you for the support and opportunities that I have had over the last thirty years.

WHEREAS, the Judge-Executive seeks to appoint Ernest Pasley to fill the unexpired term.

NOW, THEREFORE, BE IT ORDERED by the Clark County Fiscal Court as follows:

SECTION ONE. That upon the Judge-Executive seeking the appointment of Ernest Pasley to the East Clark County Water District Board of Commissioners to fill the unexpired term of Fred Farris, Ernest Pasley is hereby appointed to the term ending July 31, 2020.


SECTION TWO. The foregoing appointment shall serve out the term set out above or until a successor is duly appointed.



SECTION TWO. The foregoing appointment shall serve out the term set out above or until a successor is duly appointed.




