Pursuant to Ordering Paragraph No. 3 of the Commission's Order dated October 26, 2021, Delta Natural Gas Company, Inc. ("Delta") hereby files information related to an issuance under said Order.

Effective December 31, 2021, Delta obtained \$15 million in long-term debt from its parent company, PNG Companies LLC ("PNG"), through two issuances in accordance with the aforementioned order. The details of the note issuances are shown below:

The \$15 million debt allocated to Delta from PNG was a portion of the \$1.1 billion unsecured debt issued by PNG's parent, Essential Utilities, Inc. ("Essential"). Essential issued a \$500 million senior note due 2030 and a \$600 million senior note due 2050 at competitive market rates. Neither

Essential nor PNG allocated any additional costs to Delta that were not incurred by Essential at the time of and related to the issuance.
