Property Acquisition Update

Kentucky Power files with the Commission its September 2024 property acquisition update. The filing is being made in accordance with paragraph 49 of the Company's application. This update details the status of Kentucky Power's property acquisition efforts as of September 3, 2024.

Opposition was expressed by Volney Brent Allen and Western Pocahontas Properties.

The Company has now acquired 62 of the 108 parcels affected by the transmission line or its right-of-way. **Exhibit 1** provides further information regarding the status of the 108 parcels.
