ATTORNEY GENERAL'S NOTICE REGARDING HEARING TOPICS

The Attorney General of the Commonwealth of Kentucky, through his Office of Rate Intervention, provides notice of his intent to conduct cross examination on the following topics at the Hearing of November 30, 2021. This Notice is provided pursuant to the Commission’s Order of November 22, 2021.

In addition to those topics discussed in the November 22, 2021 Order, Kentucky Power Company (“Kentucky Power”) should provide a witness or witnesses who can offer testimony regarding:

- Any comments and/or concerns expressed by Kentucky Power employees related to the transaction and the general impact of the potential sale on employees.
- Whether further changes/amendments to the Mitchell Operating Agreement, beyond those referenced in the Case No. 2021-00421 docket, are anticipated if and when the potential sale is finalized.
- Whether and to what extent Liberty Utilities Company (“Liberty”) had input on the changes to the Mitchell Operating Agreement referenced in the Case No. 2021-00421 docket.

- The substance of any terms of any agreement in place between Kentucky Power and Liberty as those terms relate to the future operation of Mitchell.
- Filings made or to be made at the West Virginia Public Service Commission related to the proposed Mitchell Operating Agreement.

In order to avoid unnecessary questioning of witnesses who cannot address these issues, the Attorney General requests that Kentucky Power provide notice of which witness will address each of these topics prior to the November 30, 2021 Hearing.
