DATA REQUEST

RH_1_1 Explain Kentucky Power and Wheeling Power's plan regarding Mitchell. Provide updated status reports every ten days through the pendency of this proceeding.

RESPONSE

Kentucky Power and Wheeling Power currently are implementing plans to ensure the construction of the CCR project to allow the operation of the Mitchell Generating Station through December 31, 2028.

Kentucky Power Company and Wheeling Power Company are reviewing their alternatives regarding the Mitchell Generating Station in light of the July 15, 2021 decision of this Commission, and the August 4, 2021 decision of the Public Service Commission of West Virginia. No decision regarding a plan for the Mitchell Generating Station beyond that described above has been reached by either Company.

Kentucky Power will file updated status reports every ten days during the pendency of this proceeding.

September 13, 2021 Update

Wheeling Power Company and Appalachian Power Company on September 8, 2021 filed with the Public Service Commission of West Virginia their "Petition to Reopen Case and to Take Further Action" in Case No. 20-1040-E-CN. The petition requests the West Virginia Commission to provide certain confirmations, acknowledgements, and commitments regarding, *inter alia*, the Mitchell Generating Station, in light of the inconsistent orders of the Kentucky and West Virginia commissions regarding the proposed ELG work at the Mitchell Generating Station. The petition further requests that the West Virginia Commission provide the confirmations, acknowledgements, and commitments prior to the October 13, 2021 deadline under the ELG Rule for notifying the West Virginia Department of Environmental Protection concerning the ELG modifications at the Mitchell Generating Station. Finally, Wheeling Power and Appalachian Power Company indicated in the petition that there were matters in need of resolution should West Virginia decide to fully fund the ELG investment and maintain the plant in order to preserve an option to run the Mitchell Generating Station past 2028.

The West Virginia commission by order dated September 9, 2021 established a procedural schedule, and provided for a September 24, 2021 evidentiary hearing, in connection with the petition.

A copy of the September 9, 2021 order is attached as KPCO_SR_KPSC_RH_1_1_Attachment2.

Kentucky Power Company and Wheeling Power Company continue to review their alternatives regarding the Mitchell Generating Station pending action by the West Virginia Commission on the petition. Kentucky Power Company also intends to explore these issues and will work to bring the Commission a recommendation on how to handle the Mitchell operating agreement in a new docket for review.

Kentucky Power will continue to file updated status reports every ten days during the pendency of this proceeding on the status of the West Virginia decision on ELG investment.

September 23, 2021 Update

Wheeling Power Company and Appalachian Power Company on September 20, 2021 filed with the Public Service Commission of West Virginia their Reply in support of their "Petition to Reopen Case and to Take Further Action."

A copy of the Reply is attached as KPCO SR KPSC RH 1 1 Attachment3.

Kentucky Power Company and Wheeling Power Company continue to review their alternatives regarding the Mitchell Generating Station pending action by the West Virginia Commission on the petition. Kentucky Power Company will work to bring the Commission a recommendation on how to handle the Mitchell operating agreement either in Case No. 2021-00370 or in a separate docket.

Kentucky Power will continue to file updated status reports every ten days during the pendency of this proceeding.

October 4, 2021 Update

The Public Service Commission of West Virginia held an evidentiary hearing on September 24, 2021 in Case No. 20-1040-E-CN. The purpose of the hearing was to address the issues raised in Wheeling Power Company and Appalachian Power Company's September 8, 2021 "Petition to Reopen Case and to Take Further Action."

On October 12, 2021 the Public Service Commission of West Virginia issued its Order regarding Wheeling Power Company and Appalachian Power Company's September 20, 2021 "Petition to Reopen Case and to Take Further Action" affirming the earlier order that the Companies proceed with ELG at all three plants.

Kentucky Power will continue to file updated status reports every ten days during the pendency of this proceeding.

October 25, 2021 Update

Wheeling Power Company is moving forward with CCR/ELG work at the Mitchell Generating Station given the recent action by the West Virginia Commission on the petition. Kentucky Power Company will work to bring the Commission a recommendation on how to handle the Mitchell operating agreement either in Case No. 2021-00370 or in a separate docket. The Company expects to make the operating agreement filing in fourth quarter 2021 and further plans to address through that filing that Kentucky Power will only pay for CCR-related costs associated with the CCR/ELG project.

¹ The Commission Staff's data request 2-6 dated September 17, 2021 sought, as a continuing request, that the Company provide a copy of any documents filed by Wheeling Power or the Public Service Commission of West Virginia in Case No. 20-1040-E-CN and to be provided in the Company's 10-day status reports. November 4, 2021 Update

AEP has entered into an agreement to sell its Kentucky operations, which include Kentucky Power and AEP Kentucky Transco, to Liberty Utilities Corp., the regulated utility business of parent company Algonquin Power & Utilities Corporation. Liberty will own and obtain power from Kentucky Power's 50% portion of the Mitchell Plant through 2028. The sale is expected to close in the second quarter of 2022, pending regulatory approvals. The Company expects that an application for Commission approval of the transaction will be made in the fourth quarter 2021.

Kentucky Power Company will work to bring the Commission a recommendation on how to handle the Mitchell operating agreement either in Case No. 2021-00370 or in a separate docket. The Company expects to make the operating agreement filing in the fourth quarter 2021.

Kentucky Power will continue to file updated status reports every ten days during the pendency of this proceeding.

There were no documents filed by either Wheeling Power Company or the Public Service Commission of West Virginia in Case No. 20-1040-E-CN from October 25, 2021 through November 3, 2021.

November 15, 2021 Update

On November 5, 2021, Kentucky Power filed its notice of intent to file an application for approval of affiliate agreements related to the Mitchell Generating Station. The Commission assigned this proceeding Case No. 2021-00421. The Company will file its application before November 30, 2021. A comparable filing will be made at the same time in West Virginia.

Additionally, American Electric Power Service Corporation (on behalf of Wheeling Power and Kentucky Power) filed the New Mitchell Agreements and cancellation of Rate Schedules No. 303 (current Mitchell Plant Operating Agreement) with FERC on November 19, 2021. Please see KPCO SR KPSC 1 1 Attachment7 for a copy of this filing.

Kentucky Power will continue to file updated status reports every ten days during the pendency of this proceeding.

- a. Please confirm, and explain the underlying reasoning, that American Electric Power Service Corporation ("AEPSC") has withdrawn its Federal Energy Regulatory Commission ("FERC") requests to approve the operating agreement for the Mitchell plant.
- b. Please explain the impact that this withdrawal of the FERC requests will have on the timing of the Companies' request in this proceeding and the timing of the proposed revisions contemplated by the Companies' Petition.

Response WVEUG 3-02

- a. The Companies confirm that on February 7, 2022, AEPSC filed a request at FERC to withdraw the filings related to the new Mitchell agreements that were originally made on November 19, 2021. As noted in the FERC request to withdraw, the Mitchell agreements may require modifications based on orders from the Kentucky and West Virginia commissions and such amendments would then need to be filed with the FERC. In light of the on-going proceedings for the WVPSC and KPSC and in the interest of administrative efficiency, the Companies sought to withdraw the FERC filing. The Companies intend to re-file with FERC following orders from the WVPSC and KPSC.
- b. The withdrawal of the FERC requests has no impact on the Companies' request in this proceeding, as expeditious treatment is still needed. Orders from the WVPSC and KPSC will be obtained prior to re-filing at FERC, the approval from which may take up to 60 days after such a filing is made. Regulatory approvals from this Commission, the KPSC, and the FERC are all required.

APPALACHIAN POWER COMPANY and WHEELING POWER COMPANY, public utilities.

Petition for consent and approval to enter into Ownership and Operating Agreements for the Mitchell Plant.

COMMISSION ORDER

The Commission grants a motion to compel.

BACKGROUND

On November 19, 2021, Appalachian Power Company and Wheeling Power Company (together, Companies) filed a petition (Petition) for consent and approval to enter into Ownership and Operating Agreements for the Mitchell Plant that is the subject of this case (sometimes referred to as Mitchell). As a part of that Petition, the Companies requested exemption from the requirement to provide the financial information specified in Rule 21 of the Commission Rules of Practice and Procedure (Procedural Rules), 150 C.S.R. 1. Petition at 2.

The Commission granted intervenor status to the West Virginia Energy Users Group (WVEUG), the Consumer Advocate Division (CAD), the West Virginia Coal Association (WVCA) and West Virginia Citizens Action Group, Solar United Neighbors, and Energy Efficient West Virginia (CAG/SUN/EEWV). Commission Orders, January 25, 2022, and February 8, 2022.

On January 27, 2022, CAD filed a motion requesting that the Commission compel the Companies to respond to CAD Data Requests Set I, requests 1-4 and 1-5 (Motion).

On February 7, 2022, the Companies responded to CAD's Motion (Response).

DISCUSSION

CAD requested the following information from the Companies in discovery

requests:

- 1-4 Please produce the Confidential Information Memorandum or its equivalent put forward by Barclays, Goldman Sachs Co., and/or others who served as AEP's financial and strategic advisors related to the sale of Kentucky Power.
- 1-5 Please produce all information provided to AEP by Algonquin Power & Utilities Corporation subsidiary Liberty Utilities Company or others related to Liberty's plans for Kentucky Power and Mitchell if it were successful in the acquisition, including any conditions related to Mitchell included in its offer.

Requests, Set 1 (January 6, 2022).

The Companies objected to these two discovery requests:

- 5. The Companies object to Question No. 1-4 on grounds of relevance. The Companies' Petition in this matter seeks the Commission's approval of new Ownership and Operating Agreements whereby WPCo would replace Kentucky Power Company ("KPCo") as operator of the Mitchell Plant. As explained in that Petition, and regardless of the proposed sale of KPCo to Liberty Utilities Co., it is necessary for WPCo to become operator of the Mitchell Plant due to the conflicting decisions of this Commission and the Kentucky Public Service Commission ("KPSC") as to CCR/ELG upgrades at the plant. CAD Question No. 1-4 seeks only information related to the proposed sale of KPCo, which is the subject of a proceeding pending not before this Commission, but before the KPSC (see Case No. 2021-00481). Accordingly, this question is not reasonably calculated to lead to the discovery of relevant, admissible evidence in this proceeding.
- 7. The Companies object to Question No. 1-5 on the grounds that the term "all information" is vague, ambiguous, and overbroad and, further, to the extent the question seeks information that is confidential, privileged, and/or not likely to lead to the discovery of relevant, admissible evidence in this proceeding. As the Companies noted in their objection to Question No. 1-4, the proposed sale of KPCo to Liberty is the subject of a separate proceeding before a different commission (*see* KPSC Case No. 2021-00481).

Companies Objections (January 20, 2022).

Without waiving their objection, the Companies responded:

The SPA [Sale and Purchase Agreement] between AEP and Liberty Utilities (see response to CAD 1-03) and the new Mitchell Ownership Agreement and Mitchell O&M Agreement reflect the plans for both parties, including Liberty's plans for Mitchell. Specifically, the SPA states that:

- Kentucky Power and Wheeling Power will take the actions necessary to obtain the regulatory approvals of the Mitchell Ownership Agreement and Mitchell O&M Agreement;
- The new Mitchell Ownership Agreement and Mitchell O&M Agreement must receive all regulatory approvals and be signed by Kentucky Power and Wheeling Power as necessary conditions to closing the sale of Kentucky Power; and
- The new Mitchell Ownership Agreement and Mitchell O&M Agreement are exhibits to the SPA and contain what AEP and Liberty have agreed to regarding Mitchell including operations and cost allocations.

Response to Discovery Request CAD 1-05 (January 26, 2022).

CAD in its Motion to Compel amended Request 1.5 and is requesting only the parties' written offers and counter offers with respect to the anticipated transfer of KPCo to Liberty.

CAD argued that the approval of ownership and operating agreements at issue in this case and the potential purchase of KPCo by Liberty Utilities are inarguably intertwined. The responsibilities related to the future ownership and operation of the Mitchell Plant by Liberty Utilities, if it takes ownership of KPCo, are relevant to the case before this Commission. In KPSC Case No. 2021-00481, Peter Eichler testified that "Liberty's generation operations experts will monitor Mitchell's performance on behalf of Kentucky Power, and will be involved in all of the appropriate decision-making as contemplated in the Mitchell Plant Operations and Maintenance Agreement and Mitchell Plant Ownership Agreement." Direct Testimony of Peter Eichler at 31. Mr. Eichler continued to say "Mitchell nevertheless represents a major facet of the transaction. As such, a number of Liberty's staff members were involved in the review and development of different aspects of the proposed new Mitchell Agreements." Id. at 47. CAD argued that because the testimony in the Kentucky case discussed the future ownership and operation of Mitchell as a major facet of the sale of KPCo to Liberty Utilities, the two are intertwined. Additionally, "Liberty's generation operations experts will monitor Mitchell's performance on behalf of Kentucky Power, and will be involved in all the appropriate decision-making as contemplated in the Mitchell Operations and Maintenance Agreement and Mitchell Plant Ownership Agreement." KPSC Case No. 2021-0048, Direct Testimony of Peter Eichler at 31.

The Companies countered that WPCo must become the operator of the Mitchell Plant regardless of the proposed sale of KPCo to Liberty, as explained in the Companies' Petition and in the direct testimony of Christian T. Beam: therefore, the possible transfer of ownership of KPCo's undivided one-half interest in Mitchell is irrelevant. "The New Mitchell Agreements are appropriate to govern the relationship regarding the Mitchell Plant whether or not the ownership of the KPCo changes, as they address the requirements of this Commission and KPSC." Response at 4-5; Cos. Exh. CTB-D at 12. Additionally, the Companies argued that confidential communications between AEP and its financial and strategic advisors as well as "all information" provided to AEP by Liberty is not relevant to this case. CAD, however, argued that how the parties arrived at the terms of the SPA for KPCo is pertinent to this case.

Rule 13.6 of the Commission Rules of Practice and Procedure, 150 CSR 1, provides that discovery requests must be pertinent to substantial issues in the proceeding. The Commission considers Rule 26 of the W. Va. Rules of Civil Procedure when resolving or addressing discovery disputes. The Commission broadly interprets discovery and allows for discovery requests that appear reasonably calculated to lead to the discovery of admissible evidence. Trans-Allegheny Interstate Line Co., Case No. 07-0508-E-CN, Comm'n Order at 3 (May 23, 2008); Equitable Gas Co., Case No. 95-0704-G-30C, Comm'n Order at 1 (Jan. 3, 1996). The Commission agrees with CAD that the ownership and operating agreement in this case is intertwined with the potential future ownership of an undivided one-half interest in the Mitchell Plant by Liberty. Requests 1-4 and amended 1-5 are relevant and likely to lead to admissible evidence. The Commission, therefore, will grant the Motion. The Companies should answer Request 1.4 and amended Request 1.5 within five days of the date of this Order.

FINDING OF FACT

KPCo is currently before the KPSC requesting permission to sell its undivided one-half interest in the Mitchell Plant to Liberty. KPSC Case No. 2021-0048.

CONCLUSIONS OF LAW

- 1. The Commission broadly interprets discovery and allows for discovery requests that appear reasonably calculated to lead to the discovery of admissible evidence. <u>Trans-Allegheny Interstate Line Co.</u>, Case No. 07-0508-E-CN, Comm'n Order at 3 (May 23, 2008); <u>Equitable Gas Co.</u>, Case No. 95-0704-G-30C, Comm'n Order at 1 (Jan. 3, 1996).
- 2. The potential future ownership by Liberty of an undivided one-half interest in the Mitchell Plant is relevant to the ownership and operating agreement presented for Commission approval in this case. Request 1-4 and amended Request 1-5, therefore, are likely to lead to admissible evidence.

ORDER

IT IS THEREFORE ORDERED that the Motion to Compel filed by the Consumer Advocate Division is granted and the Companies should file their responses to Request 1.4 and modified Request 1.5 within five days of the date of this Order. If the information is deemed confidential by the Companies, then the Companies should file the information under seal and file a motion for protective treatment.

IT IS FURTHER ORDERED that the Executive Secretary of the Commission serve a copy of this Order by electronic service on all parties of record who have filed an e-service agreement, by United States First Class Mail on all parties of record who have not filed an e-service agreement, and on Staff by hand delivery.
