Notice is hereby given that the Public Service Commission of Kentucky (the "Commission") will conduct a public hearing beginning at 9:00 a.m. Eastern Daylight Savings Time on Tuesday, October 5, 2021 in the Richard Raff Hearing Room (Hearing Room 1) at its offices at 211 Sower Boulevard, Frankfort, Kentucky 40601. The hearing is for the purposes of discussing American Electric Power Company's strategic review of Kentucky assets; ownership of the Mitchell Generating Station; transmission planning and operation, and other related matters as part of Case No. 2021-00370 initiated by the Commission on September 15, 2021. This hearing will be streamed live and may be viewed on the PSC website, [psc.ky.gov](http://psc.ky.gov). Public comments may be made at the beginning of the hearing.
