



Dear Mr. Greynolds:

The Campbellsville Water & Sewer Committee met on May 13, 2021 and recommended to the Campbellsville City Council an increase in East Casey County Water District's rate for water service from Campbellsville Water.

The Wholesale Water Rate for East Casey County Water District will increase from \$2.35 per 1000 gallons to \$2.54 per 1,000 gallons.

The Campbellsville City Council had its First Reading of the proposed rate increase on Monday, May 17, 2021, and the Second Reading will be heard on Monday, June 21, 2021.

The proposed rate increase will be effective for water used on and after August 1, 2021.

Notice is hereby given that Campbellsville Municipal Water & Sewer (Campbellsville Water) plans to file with the Public Service Commission on or before July 1, 2021 to increase its rates for wholesale water service to East Casey County Water District effective for service on and after August 1, 2021. The proposed rates are as follows:

AN ORDINANCE AMENDING ORDINANCE 19-04 ESTABLISHING  
WATER RATES FOR CERTAIN WHOLESALE CUSTOMERS  
OF THE CITY OF CAMPBELLSVILLE, KENTUCKY  
THROUGH THE CAMPBELLSVILLE WATER & SEWER SYSTEM

\* \* \* \* \*

Whereas, the City of Campbellsville through the Campbellsville Water & Sewer System provide water to persons residing within the corporate boundaries of the City of Campbellsville and to persons residing in Taylor County, Kentucky, but outside the corporate boundaries of the City of Campbellsville; and

Whereas, the City of Campbellsville desires and intends to provide water and sewer services to the residents of the City of Campbellsville and Taylor County, Kentucky in such a way as to cover its costs, but not to seek a profit; and

Whereas, the cost of operating the Campbellsville Water & Sewer System has increased over time and the infrastructure owned by the Campbellsville Water & Sewer System is in need of repairs and improvements and will need repairs and improvements in the future; and

Whereas, wholesale water rates have not been increased for residential customers since 2004 and the revenues generated from the operations of the Campbellsville Water & Sewer System at the existing rates are inadequate to cover the costs associated with continued operations, repairs and improvements to the system; and

Whereas, the Campbellsville Water & Sewer System has a written contract for providing water to the Lebanon Water Works which involved the construction of certain infrastructure to accommodate the Lebanon Water Works's need for water now and in the future. The rate charged to the Lebanon Water Works is governed by the terms and conditions of the written contract and this Ordinance does not govern the rates charged or to be charged to Lebanon Water Works

Whereas, the City Council of the City of Campbellsville intends to raise rates for certain wholesale water customers so as to cover the increased costs of operation which the Campbellsville Water & Sewer System have incurred and are incurring.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMPBELLSVILLE, KENTUCKY as follows:

1. Water Rates for Wholesale Customers. Beginning on July 1, 2019 2021, water rates for the following wholesale customers shall be as follows:

### PUBLIC NOTICE EAST CASEY COUNTY WATER DISTRICT PURCHASED WATER ADJUSTMENT

Due to increases in the wholesale rate for water purchased from the City of Campbellsville, the East Casey County Water District has applied to the Kentucky Public Service Commission for a rate increase to cover its increased costs. The rates contained herein are the rates proposed by East Casey County Water District for all customers, however the Public Service Commission may order rates to be charged that are higher or lower than the rates proposed in this notice. Any corporation, association, body public or person may request leave to intervene by motion within thirty (30) days after notice of the proposed rates change is given. A motion to intervene shall be in writing, shall be submitted to the Executive Director, Kentucky Public Service Commission, 211 Sower Boulevard, P. O. Box 615, Frankfort, KY 40602, and shall set forth the grounds for the motion including the status and interest of the party. The application may be reviewed at the East Casey County Water District at 690 South Wallace Wilkinson Boulevard Liberty, KY 42539 and the Kentucky Public Service Commission office listed above Monday through Friday, 8:00 a.m. to 4:30 p.m., or through the Commission's website at <http://psc.ky.gov>.

The proposed rate increase of \$0.02/1,000 gallons will compensate for the higher wholesale purchase water rates proposed by the City of Campbellsville.

RESOLUTION

RESOLUTION OF THE EAST CASEY COUNTY WATER DISTRICT, AUTHORIZING THE IMPLEMENTATION OF NEW RATES, SUBMITTING NEW RATES TO THE PUBLIC SERVICE COMMISSION AND AUTHORIZING A REPRESENTATIVE TO SIGN ALL RELATED DOCUMENTS

WHEREAS, the City of Campbellsville is raising the wholesale cost of water pending approval from the Public Service Commission; and

WHEREAS, the District desires to adjust its rates to its customers to reflect the wholesale rate increase.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the East Casey County Water District as follows:

SECTION 1. That the District hereby accepts the rates awarded by the Public Service Commission pending approval and approves the raising of rates by a compensating amount to its customers.

SECTION 2. That the Chairperson is hereby authorized, directed and empowered by the District's Board of Commissioners to execute the necessary documents, and to otherwise act on behalf of the District to implement the changed rates.

SECTION 3. This Resolution shall take effect immediately upon passage.
