

Comes Paducah Water Works (“PWW”), through counsel, and respectfully requests that the Commission grant a deviation from requirement #3 of its Order dated December 6, 2021 approving the merger of PWW and West McCracken County Water District (“WMW”). As grounds therefore, PWW states that the transfer of ownership from WMW to PWW will not take place until February 4, 2022, as a result, financial documents are not currently available to satisfy this requirement.

Wherefore, PWW respectfully requests that the Commission grant the following deviation: WMW shall have 60 days from the date the transfer is completed to file with the Commission financial and statistical reports as required by 807 KAR 5:006, Section 4, for the reporting period from January 1, 2021 to December 31, 2021 and the reporting period from January 1, 2022, to the date of merger.






