Pursuant to the Order entered by the Public Service Commission December 6, 2021, the Commission approved the transfer of ownership of the West McCracken Water District’s (“District”) entire water distribution system to Paducah Water Works.

One of the conditions within the foregoing Order was that within five (5) days of the date the transfer was completed, the parties were to notify the Commission. Accordingly, please allow this Notice to notify the Commission that the transaction was closed and all assets were transferred on February 2, 2022.

Proceedings have been initiated to dissolve the district pursuant to KRS 74.367. A copy of the dissolution order issued by the County Judge Executive will be filed with the Commission within five (5) days after such order is issued.

The financial and statistical reports required by the Commission’s Order are being prepared at this time and will be submitted to the Commission pursuant to its Order entered February 4, 2022.


