THE CARLISLE CITY COUNCIL MET IN REGULAR SESSION ON MONDAY, JANUARY 7TH
WITH MAYOR CLARK PRESIDING.

MEETING WAS CALLED TO ORDER AT 7:00 P.M. BY MAYOR CLARK WITH A MOMENT OF SILENCE.

MEMBERS PRESENT WERE ERICA BUSSELL, SANDY RITCHIE, ALICE HUGHES, DOUG GARRETT,
DEBBY ECTON AND DENNIS ALLISON.

CHIEF DARRELL LAYNE AND CITY ATTY. HENRY (SKIP) WATSON.

MAYOR'S COMMENTS:

CHANNEL 18 IS HERE REGARDING A COMMENT MADE ON SOCIAL MEDIA. I DON'T CONDONE
THIS, THE INDIVIDUAL IS IN A RANKING POSITION. I WILL HAVE GUIDELINES SET UP AND TALK TO ALL
EMPLOYEES. THIS IS A PERSONNEL ISSUE AND I WILL HANDLE IT.

THE CITY FAILED TO PAY OUR TAX LIABILITY, I PLAN ON GOING TO FRANKFORT AND
NEGOTIATING DOWN THE PENALTY AND INTEREST.

LARRY JOLLY SIGNED AN AGREED ORDER ON THE CHLORINE ROOM. I HAVEN'T SEEN IT YET, WE ARE GOING TO HAVE TO RAISE THE CHLORINE ROOM SIX FEET OFF THE GROUND.

THE GAS SYSTEM HAS HAD NOTHING PAINTED OR THE LEAKS FIXED. WE ARE GOING TO FIX ALL THAT. THERE IS A LEAK AT TRACKS AND UPPER SYCAMORE WE WILL GET FIXED.

ANY EXTRA TRASH WILL BE PICKED UP, BOXES, BAGS, ETC. AND WE WILL LOG ALL EXTRA TRASH AFTER THE 3 TIME, WE WILL SEND THEM A LETTER NOTIFYING THEM THEY NEED ANOTHER HERBIE.

RUN DOWN HOUSES NEED TO BE CLEANED UP AND A LIEN PUT ON THE PROPERTY AS LONG AS WE HAVE THE MONEY TO DO IT.

WE ARE SLACKING ON CREDIT BECAUSE WE DON'T HAVE A FINANCIAL STATEMENT TO GIVE THEM.

THE INVESTIGATION IS STILL ON GOING. I PLAN ON HAVING A CALLED MEETING WHEN ALL IS DONE.

IF YOU SEE AN ISSUE CALL ME, I'LL GIVE YOU MY CELL NUMBER.

I WILL BE ASKING FOR A MEETING WITH BOTH WATER DISTRICTS. NEED TO GET THEIR PRICES RAISED.

I HAVE A LONG LIST OF THINGS TO GO OVER WITH THE EMPLOYEES. NO EMPLOYEE IS TO USE ANYTHING FOR PERSONAL GAIN. OVERTIME WILL BE HELD TO A MINIMUM. HAVE A FEW CHANGES FOR THE WATER PLANT.

IF IT IS WRONG WE ARE GOING TO FIX IT.

GAS AND WATER WHEN READ WILL BE ENTERED ON PAPER AND INTO THE COMPUTER.

I WILL LOOK AT ALL PLANNING AND ZONING PERMITS. THE MONEY WILL STAY IN THE CITY NOT GOING TO PAY ANYONE A PERCENTAGE.

MOTION BY ALLISON AND SECOND BY GARRETT TO APPOINT RONNIE AS THE ABC ADMINISTRATOR.

JIM BIDDLE GAVE A REPORT ON THE FIREMAN TRAINING.


