In general, some of the data requested in the Third Post Hearing RFI has been provided earlier, to wit: NCWD and S/BWD requested data for the period 1 JAN 2020 thru 30 JUN 2021 has been provided earlier.

1. 3dPHRFI #1: In earlier Exhibits, the City of Carlisle provided data for each of the four (4) meters from which NCWD draws potable water. Beginning in DEC 2021 this was changed, and the attached Exhibit reflects four (4) readings for the meters, but on the same report.
