

CITY OF CARLISLE
ORDINANCE NO. 2, 2005

AN ORDINANCE AMENDING VARIOUS SECTIONS OF CHAPTER 51 OF THE CODE OF ORDINANCES, RELATING TO WATER AND SEWERS. AS FOLLOWS: INCREASING WATER RATES; INCREASING SEWER RATES; AND CHANGING THE EFFECTIVE DATE OF THE ANNUAL COST OF LIVING INCREASE IN WATER, SEWER, AND TRASH COLLECTION RATES FROM JULY 1, TO APRIL 1, OF EACH YEAR.

Be it ordained by the City of Carlisle:

Section 1. That Section 51.42 of the Code of Ordinances be and hereby is amended to read as follows:

(A) Section 51.42 Water Rates. All water customers of the City of Carlisle beginning with the April 2005 bills (received May, 2005) July, 2000 shall pay the following rates for water:

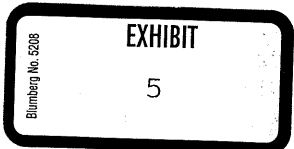
The rate for all water hauled from the water plant is 7.25 ~~6-25~~ per 1,000 gallons.

(B) All water customers shall pay a minimum charge per month in an amount equal to the rate for the first 2,000 ~~1,000~~ gallons or less as set out above, and the City Clerk/Treasurer shall so bill the customers.

(C) Industrial Rate: Any Industrial water customer using in excess of an average of three ~~five~~ million gallons (3 ~~5~~ MG) of water per month each month for the previous (12) month period shall qualify for the Industrial rate. ~~There will also be a payment of a monthly service charge of \$250.00 on industrial rate customers.~~

Section 2. That Section 51.44 of the Code of Ordinances is amended to read as follows:

(A) Section 51.44 Sewer Charge. The following service rates shall apply beginning with April 2005 bills (received May, 2005) for all bills beginning July, 2000.

(B) Sewer service charges shall be based upon water usage. The billing period shall be monthly. The minimum monthly sewer service charge for inside city customers shall be \$13.61 \$6-45. The minimum monthly sewer service charge for outside city customers shall be \$17.69 \$8-40.

Section 3. That Section 51.47 of the Code of Ordinances be and hereby is amended to read as follows:

Water, sewer and trash collection rates shall be increased annually, effective with the April 2006 billing (received May 2006) with the start of a fiscal year, based on the change in the Consumer Price Index from the previous year. Nothing in this section shall prevent or preclude the city from increasing water, sewer or trash collection rates in excess of C.P.I. change, nor limit the city to increasing rates only effective with the April billing in any given year at the start of the fiscal year.

Section 4. That this Ordinance shall be effective upon passage, approval, and publication in full as required by law.


