ORDINANCE NO. 7, 1988

AN ORDINANCE AMENDING AN ORDINANCE PASSED 9TH JULY, 1984 CHANGING WATER RATES TO A MINIMUM OF \$6.00 INSIDE CITY LIMITS, \$6.80 OUTSIDE CITY LIMITS FOR THE FIRST 1,000 GALLON; AUTHORIZING AN INDUSTRIAL RATE FOR AVERAGE USERS OF 5 MILLION GALLONS PER MONTH OR ABNORMAL USEAGE FOR EACH MONTH IN THE PREVIOUS YEAR.

BE IT ORDAINED BY THE CITY OF CARLISLE, KENTUCKY:

SECTION 1: That Ordinance 9 - 1984 enacted 9th July, 1984 is amended as follows:

A. Water Rates. All water customers of the City of Carlisle beginning with bills due November, 1988 shall pay the following rates for water:

The rate for all water hauled from the water plant is $\frac{\$4.50}{\$4.99}$ (\$4.99) per 1,000 gallons.

- \underline{B} . All water customers shall pay a minimum charge per month in an amount equal to the rate for the first 1,000 gallons or less as set out above, and the City Clerk/Treasurer shall so bill the water customers.
- C. Industrial Rate. Any Industrial water customer using in excess of an average of five million gallons (5MG) of water per month each month for the previous twelve (12) month period shall quality for the Industrial rate. There will also be a payment of a monthly service charge of \$100.00 on Industrial Rate Customers.
- D. Penalty. A penalty of 10% of the bill will be assessed on all amounts not paid by the due date, which due date is 10 working days after the bill is postmarked.
- E. There shall be a charge for cut off of \$10.00 per meter. There shall be an additional charge of \$25.00 per meter if meter has to be removed and then replaced because meter was turned on without authorization of City Employee. The hours for reconnecting a service is 8:00 A.M. to 4:30 P.M. Monday through Friday except legal holidays.
