NOTICE OF FILING TESTIMONY IN SUPPORT OF JOINT STIPULATION
OF TRAVIS KAVULLA**

Comes now XOOM Energy Kentucky, LLC (“XOOM”), by and through counsel, and notifies the Kentucky Public Service Commission (“Commission”) of its filing of Testimony in Support of the Joint Stipulation of Travis Kavulla (“Mr. Kavulla”). In support of this Notice, XOOM states as follows:

1. On June 10, 2022, the Commission entered an Order setting this matter for a hearing on September 29, 2022.
2. On September 22, 2022, after negotiations with the intervenors in this matter, Columbia Gas of Kentucky (“Columbia”) filed a Joint Stipulation and Settlement Agreement (“Stipulation”). This Stipulation represents a unanimous and complete settlement of all the issues raised in this proceeding.
3. After discussions with Commission Staff, XOOM is filing testimony in support of the Stipulation. A copy of Mr. Kavulla’s testimony in support of the Stipulation is attached as **Exhibit 1**.
4. The filing of this testimony will not affect the previously established procedural schedule for this case.
