**XOOM ENERGY KENTUCKY, LLC’S  
NOTICE OF FILING REVISED DIRECT TESTIMONY OF TRAVIS KAVULLA**

Comes now XOOM Energy Kentucky, LLC (“XOOM”), by and through counsel, and notifies the Kentucky Public Service Commission (“Commission”) of its revised direct testimony of Travis Kavulla (“Mr. Kavulla”). In support of this Notice, XOOM states as follows:

1. On December 7, 2021, the Commission entered an Order setting the deadline for intervenor testimony as March 25, 2022.
2. Pursuant to the Commission’s Order, on March 25, 2022, XOOM filed the Direct Testimony and Exhibits of Mr. Kavulla.
3. On pages seven to nine of his direct testimony, Mr. Kavulla compares XOOM’s 12-month fixed price product to Columbia Gas of Kentucky’s (“Columbia”) supply service rate from September 2021 until March 2021. At the time of filing Mr. Kavulla’s direct testimony in March, the rate for Columbia’s supply service effective June 2022 was unknown.
4. The rate for Columbia’s supply service for the three-month period of June 2022 to September 2022 is now available. Accordingly, XOOM has the necessary data to compare the price paid by customers that purchased XOOM’s 12-month fixed term product with the rate paid by customers taking service from Columbia for the same time period of September 2021 until August 2022.

5. The revised direct testimony of Mr. Kavulla contains the updated figures showing savings realized by XOOM's customers versus Columbia's price to compare for the full 12-month product term, as well as updated analysis regarding savings. The updated information will make for a more complete record in this proceeding and a more accurate comparison of XOOM's price versus the utility's price to compare.

6. A clean copy of Mr. Kavulla's revised direct testimony is attached as **Exhibit 1**. A redlined version of the revised direct testimony compared to the original direct testimony is attached as **Exhibit 2**.

7. The filing of this revised direct testimony will not affect the previously established procedural schedule for this case.

Wherefore, XOOM respectfully notifies the Commission of its filing and submits the revised Direct Testimony of Travis Kavulla.
